DECORUM POLICY: The City of Deltona has a significant interest in conducting orderly and efficient public meetings, which includes preventing disruption, promoting civility, and preserving decorum. To that end, behavior which disrupts or impedes the efficient and orderly conduct of any public meeting, as determined by the Mayor, or presiding officer, or a majority of the City Commission, is not permitted. The Mayor, or presiding officer, or a majority of the City Commission, may interrupt, warn, or terminate a speaker's statement when that statement is too lengthy, personally directed, abusive, obscene, irrelevant, or otherwise reasonably perceived to be a disruption to the fair and orderly progress of the discussion at hand. The Mayor, or presiding officer, or a majority of the City Commission, may also interrupt any part of the meeting to warn any individual that they are being disruptive or otherwise impeding the efficient and orderly conduct of the meeting. The Mayor, or presiding officer, or a majority of the City Commission, may require any individual to leave a public meeting for its duration if that individual is unable to observe this Policy after being warned. Should an individual be required to leave a meeting for violating this Policy, that person shall be escorted from Commission Chambers by a Volusia Sheriff's Deputy.

Background: The application packets were mailed to each school, placed on the

website, and distributed to City facilities. The William S. Harvey Deltona Scholarship Advisory Board selected 13 applicants to receive the 2024 scholarship awards. B. Request for approval of an increase in the amount awarded from the William S. Harvey Deltona Scholarship Advisory Board (WSHDSB) - Joyce Raftery, City Clerk's Department (386) 878-8502.

Strategic Goal: Internal and External Communication.

Background: The board met on March 14, 2024, and made two requests. The first

is that the City Commission increase future scholarship funds from \$25,000 to \$50,000. This same request was made by the board in

2023 to increase the funds from \$30,000 to \$50,000 and the Commission at that time agreed. However, in 2024 due to budget constraints, the scholarship was lowered to \$25,000 which is \$5,000 less than previous years. If the Commission is not in agreement with the \$50,000, the board requests that the amount go back to the \$30,000 which was the agreed upon amount since 2016.

If the Commission would approve the increase to \$50,000 the second request is to change future packet contents to reflect the award range of no more than \$5,000 (up from \$3,000) and no less than \$1,000 to qualified applicants.

C. Request for approval of Veteran Enforcers Motorcycle Association's Deltona Memorial Day Ride Event - Mark Manning, Parks & Recreation (386) 878-8905.

Strategic Goal: Fiscal Issues

Background:

On January 16th, 2024, members of VEMA came before the City Commission to request support/assistance regarding a Memorial Day event that is planned for Monday, May 27th, 2024, at City Hall. The purpose of the event is to provide an opportunity for members of all branches of the military to come together and recognize and honor those who have given their life in service of our country while providing support for current veterans and active members of Deltona and West Volusia. As part of the event VEMA will have multiple food trucks, merchandise vendors and a band providing live music for those in attendance. The approximate cost for staff assistance, janitorial supplies, application, and fire inspection fees is not to exceed one thousand dollars (\$1,000.00). At the January 16th, 2024, City Commission meeting the commission gave unanimous verbal approval to provide support for this event. This item formalizes the verbal approval that was given at the January 16th, 2024, for in-kind services.

Pifer Construction Company, Inc. of Daytona Beach, Florida for the upland, Phase I Site Restoration Efforts associated with the 4B Project in an amount not to exceed \$144,781.00 - Phyllis Wallace, Interim Public Works Director (386) 878-8965.

Strategic Goal: Infrastructure

Background:

The project known as the Alexander Avenue 4B Intake Project (4B Lakeshore) has been determined to be un-constructable. As the City works with the other project partners including but not limited to the SJRWMD, FDEP and the West Volusia Water Supply Committee for full & complete project closeout, it was determined that the upland site (landscaping) restoration was the prudent step in the project closeout.

The landscaping plan is intended to restore as best as possible the natural state of vegetation prior to project cleaning & construction activities. The plant materials chosen closely replicate what was originally there, except in size. The project also includes removal of electrical panels/transformers, roadway repair/restoration as well as refurbishment of the shell boat parking lot. This restoration effort will compliment what was undertaken, inhouse, on the shoreline of Lake Monroe a few months ago.

The City solicited bids with notification being broadcast to 885 companies and there were 20 plan holders and 3 watchers with only 1 bid received. The City did not require a mandator pre-bid meeting & site inspection but received only 1 bid. That bid from AG Pifer Construction Company, Inc. is within industry standards and prior work efforts with this firm have been completed to the satisfaction of the City of Deltona.
