A RESOLUTION OF CITY OF DELTONA, FLORIDA; **AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE THE JOINT PROJECT AGREEMENT BETWEEN** THE COUNTY OF VOLUSIA AND THE CITY OF DELTONA FOR THE ELKCAM BOULEVARD AT LAKE HELEN OSTEEN **FLOOD** ROAD **MITIGATION PROJECT** THROUGH THE HOUSING AND URBAN DEVELOPMENT (HUD) COMMUNITY DISASTER BLOCK **GRANT-**DISASTER RECOVERY (CDBG-DR); PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, Volusia County (the "County") has received Community Development Block Grant – Disaster Recovery ("CDBG-DR") funds from the U.S. Department of Housing and Urban Development ("HUD") Grant B-23-UN-12-0005 to aide citizens of Volusia County in their recovery from Hurricane Ian; and

WHEREAS, the City has a project, the mitigation of flooding through pipe and ditch bottom inlet installation, and, in conjunction with the County, has determined that the Elkcam Boulevard at Lake Helen Osteen Road Flood Mitigation project is eligible and meets all of the requirements of HUD Grant B-23-UN-12-0005; and

WHEREAS, under HUD CDBG-DR Grant B-23-UN-12-0005, the anticipated total project budget is eight hundred forty-five thousand five hundred seventy five dollars and zero cents (\$845,575.00) with a fifty percent (50%) cost share of CDBG-DR Funds in the amount of four hundred twenty-two thousand seven hundred and eight-seven dollars and fifty cents (\$422,787.50) and four hundred twenty-two thousand seven hundred and eight-seven dollars and fifty cents (\$422,787.50) to be matched by the City of Deltona (the "City"); and

WHEREAS, the City recognizes the benefits of receiving improvements to the stormwater at the intersection of Elkcam Boulevard at Lake Helen to promote flood risk reduction, environmental resilience, and public benefit consistent with the intent of the Transform386 Programs; and

WHEREAS, the City Commission finds it to be in the best interest of the City to enter into the Joint Project Agreement with the County for the Elkcam Boulevard at Lake
