**Background:** The applicant would like to discuss a proposed single family residential development with accommodating project-specific infrastructure such as parks, stormwater ponds, utilities, lift stations, and residential roadways.

#### Staff Comments:

- Not in the Joint Planning Area (JPA).
- Would need a Comprehensive Plan Amendment and Rezone.
  - In City's Land Development Code refer to Sections 110-1101 and 110-319.
  - Section 110-319 is currently under zoning in progress, this would need to follow new regulations.
  - Refer to the Future Land Use Element in the Comprehensive Plan, for land use designations.
- Ensure wetland buffers are followed.

 A neighborhood meeting will be required per Section 74 in the LDC, that is currently being updated.
