

**ORDINANCE NO. 01-2022**

**AN ORDINANCE OF THE CITY OF DELTONA, FLORIDA, AMENDING THE OFFICIAL ZONING MAP TO REZONE ±19.84 ACRES OF LAND LOCATED EAST SIDE OF PARMA DRIVE FROM CITY OF DELTONA SINGLE FAMILY CLASSIFICATION (R1) TO RESIDENTIAL PLANNED UNIT DEVELOPMENT (RPUD); PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Deltona, Florida, has received an application to rezone ±19.84 acres from City of Deltona zoning classification of Single Family (R1) to Residential Planned Unit Development (RPUD); and,

**WHEREAS**, the City of Deltona, Florida, and its Land Planning Agency have complied with the requirements of the Municipal Home Rule Powers Act, sections 166.011 et. seq., Florida Statutes, in considering the proposed RPUD rezoning; and

**WHEREAS**, after said public hearing, the City Commission of the City of Deltona, Florida, has determined that the RPUD zoning is consistent with the Comprehensive Plan of the City of Deltona, Florida.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA, as follows:**

**Section 1:** Located in the City of Deltona, Florida, this Parma Drive property zoning amendment includes Exhibit “A”, Development Agreement as a written agreement for the residential planned unit development, Exhibit “B”, Legal Description depicting the land hereby rezoned from R1 to RPUD, and Exhibit “C”, Master Development Plan. The identification number included for this zoning amendment is 8103-00-00-0250.

**Section 2:** This Ordinance is adopted in conformity with and pursuant to the Comprehensive Plan of the City of Deltona, the Local Government Planning and Development Act, Sections 163.161 et. Seq., Florida Statutes, and the Municipal Home Rule Power Act, Sections 166.011 et. seq., Florida Statutes.

**Section 3. Conflicts.** Any and all Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**Section 4. Severability.** If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect any other provision or application of this Ordinance which can be given effect without the invalid provision or application.

**Section 5. Effective Date.** This Ordinance shall take effect immediately upon its final adoption by the City Commission.
