

## **RESOLUTION NO. 2025-135**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA, AFFIRMING THE ESTIMATED ASSESSMENT RATES FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2025, FOR STORMWATER, STREETLIGHTING, AQUATIC WEED CONTROL, AND NUISANCE ABATEMENT; PROVIDING FOR CONFLICTS, SEVERABILITY, SCRIVENER'S ERRORS, AND AN EFFECTIVE DATE.**

**WHEREAS**, the City Commission of Deltona, Florida (the "Commission"), adopted Resolution 2025-79 relating to the provision of Stormwater Services, Facilities, and Programs and providing and estimated assessment rate for the Fiscal Year beginning October 1, 2025; and

**WHEREAS**, the Commission adopted Resolution 2025-81 relating to the provision of Streetlighting Services, Facilities, and Programs and providing and estimated assessment rate for the Fiscal Year beginning October 1, 2025; and

**WHEREAS**, the Commission adopted Resolution 2025-82 relating to the provision of Aquatic Weed Control Services, Facilities, and Programs for Lake McGarity and providing and estimated assessment rate for the Fiscal Year beginning October 1, 2025; and

**WHEREAS**, the Commission adopted Resolution 2025-83 related to the provision of Nuisance Abatement Services and providing and estimated assessment rate for the Fiscal Year beginning October 1, 2025; and

**WHEREAS**, the Commission desires to affirm and adopt the estimated assessment rates for the Fiscal Year beginning October 1, 2025, as set forth in Resolutions 2025-79, 2025-81, 2025-82, and 2025-83.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:**

**Section 1. Resolutions Affirmed.** That the intent and purpose of Resolutions 2025-79, 2025-81, 2025-82, and 2025-83 are hereby adopted and affirmed in their totality, including the estimated assessment rates for the Fiscal Year beginning October 1, 2025.

**Section 2. Conflicts.** All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

**Section 3. Severability.** If any clause, section, part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, the validity of the remaining portions or applications of this resolution shall not be affected thereby.

**Section 4. Scrivener's Errors.** Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.
