

RESOLUTION NO. 2025-149

**A RESOLUTION OF THE CITY OF DELTONA, FLORIDA;
APPROVING WORK AUTHORIZATION FOR
STORMWATER ENGINEERING SERVICES FOR LAKE
WINDSOR PUMP STATION/COURTLAND BOULEVARD
STORMWATER FORCEMAIN RELOCATION, PURSUANT
TO THE CONTINUING CONTRACT WITH PEGASUS
ENGINEERING, LLC PER RFQ#2020-08; PROVIDING FOR
IMPLEMENTATION AND AN EFFECTIVE DATE.**

WHEREAS, the existing Stormwater Force Main in the Cottondale Drive and Covington Drive area was installed and designed prior to the City of Deltona (the “City”) incorporation in 1995; and

WHEREAS, the Force Main has surpassed its useful life, and replacement is necessary to prevent operational failures; and

WHEREAS, relocating the infrastructure to the right-of-way of Courtland Boulevard will facilitate maintenance and repairs, mitigate potential damage to residential properties in the event of infrastructure failure, and promote the health and safety of the community; and

WHEREAS, pursuant to the Continuing Contract awarded via RFQ#2020-08 (the “RFQ”), Pegasus Engineering, LLC (the “Consultant”) submitted a proposal to the City dated September 29, 2025, to provide necessary engineering services related to the replacement and relocation of the Stormwater Force Main, which is attached hereto and incorporated herein as Exhibit “A” (the “Proposal”); and

WHEREAS, the City Commission desires to approve the Consultant’s Proposal, pursuant to the Continuing Contract awarded via the RFQ in an amount not to exceed One Hundred Ninety-Five Dollars Nine Hundred and Thirty Dollars (\$195,930.00).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That the above recital is hereby adopted, confirmed, and incorporated herein.

Section 2. Purchase Approved. That the Proposal, in substantially the form which is attached hereto, is approved, and the City Manager or his designee is authorized

to accept the Proposal and execute and implement the Work Authorization, once approved by the City Attorney as to form and legal sufficiency.

Section 3. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
