This proposal is based on a Site Visit on 7/25/2023

- 1) PROVIDE AND INSTALL CLASS 1 EXPOSED ALUMINUM ROOF TOP LIGHTNING PROTECTION SYSTEM WITH COPPER DOWNLEAD CONDUCTORS TERMINATING AT 5/8"X20" COPPER CLAD GROUND RODS. SEE ADDER BELOW FOR CLASS 1 COPPER COUNTERPOISE FOR ALL STRUCTURS/BUILDINGS WITH INTERCONNECTIONS BETWEEN FOR WHOLE PLANT GROUND GRID. SEE PAGE 2 FOR LIST OF BUILDINGS/STRUCTURES INCLUDED.
- 2) ALL WORK TO BE IN STRICT ACCORDANCE WITH U.L. 96A, N.F.P.A. 780 & L.P.I. 175.
- 3) SURGE SUPPRESSION DEVICES <u>NOT INCLUDED</u>. <u>NOTE: U.L. REQUIRES SPD PER UL1449 3RD ED.</u>
- 4) ALL FLASHINGS & ANY SPECIAL REQUIRMENTS THAT MAY BE REQUIRED BY THE ROOFING CONTRACTOR OR ROOF <u>MANUFACTURER TO BE SUPPLIED AND INSTALLED BY OTHERS</u>. (IE: SACRIFICIAL PADS, PAVERS, HEATWELD STRAPPING AND ANY OTHER SPECIAL METHODS THAT MAY BE REQUIRED.)
- 5) ALL REQUIRED PVC CONDUIT WITH PULL STRINGS FOR DOWNLEAD CONDUCTORS TO BE SUPPLIED AND INSTALLED <u>BY TLP</u>. APPROX 300' REQ'D. ALL CONDUIT FOR LP MUST BE STRAPPED 3' OC PER UL 96A. PER SITE.
- 6) ANY REQUIRED CONCRETE AND/OR ASPHALT CUTTING OR PATCHING OR JACK & BORING THAT MAY BE REQUIRED BY OTHERS.
- 7) WE <u>HAVE INCLUDED</u> FORMAL CERTIFCATION BY UNDERWRITER'S LABORATORIES. FOR ALL ELIGIBLE STRUCTURES/BUILDINGS.
