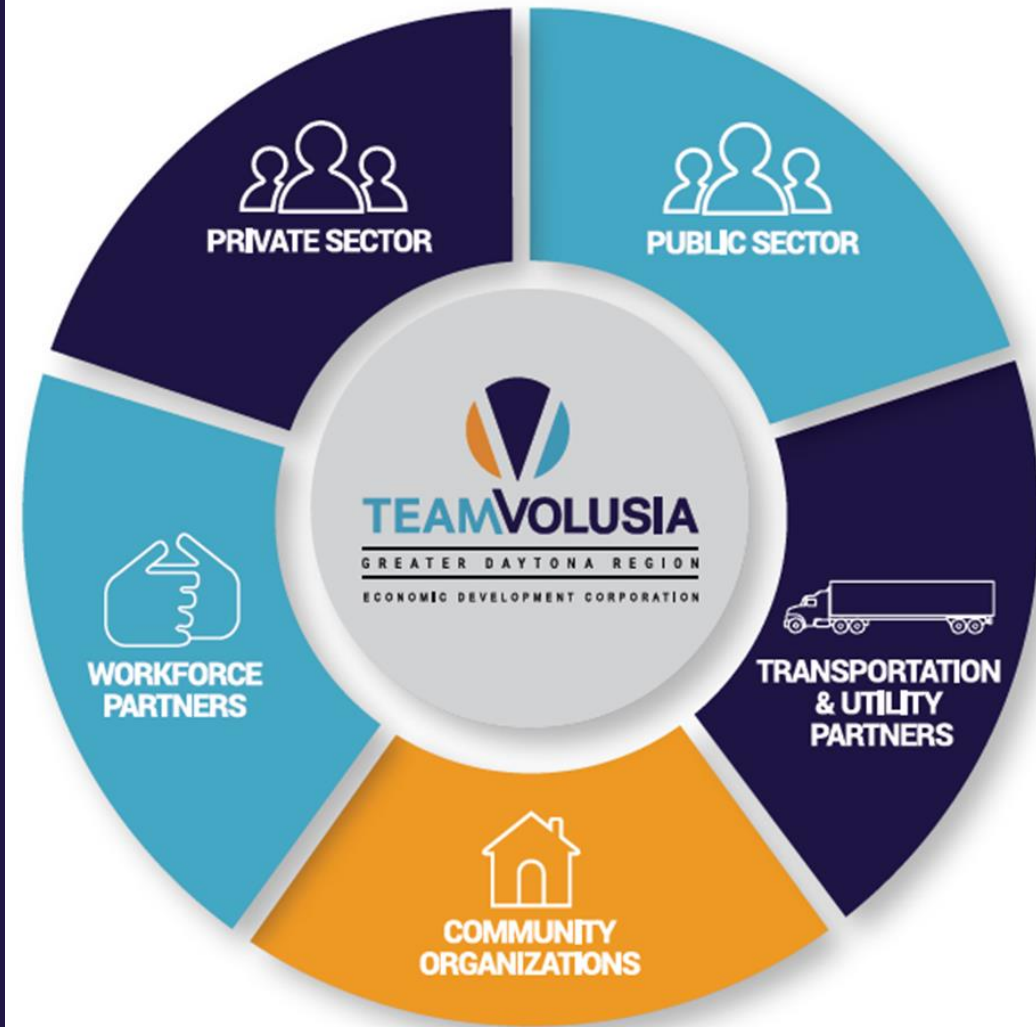

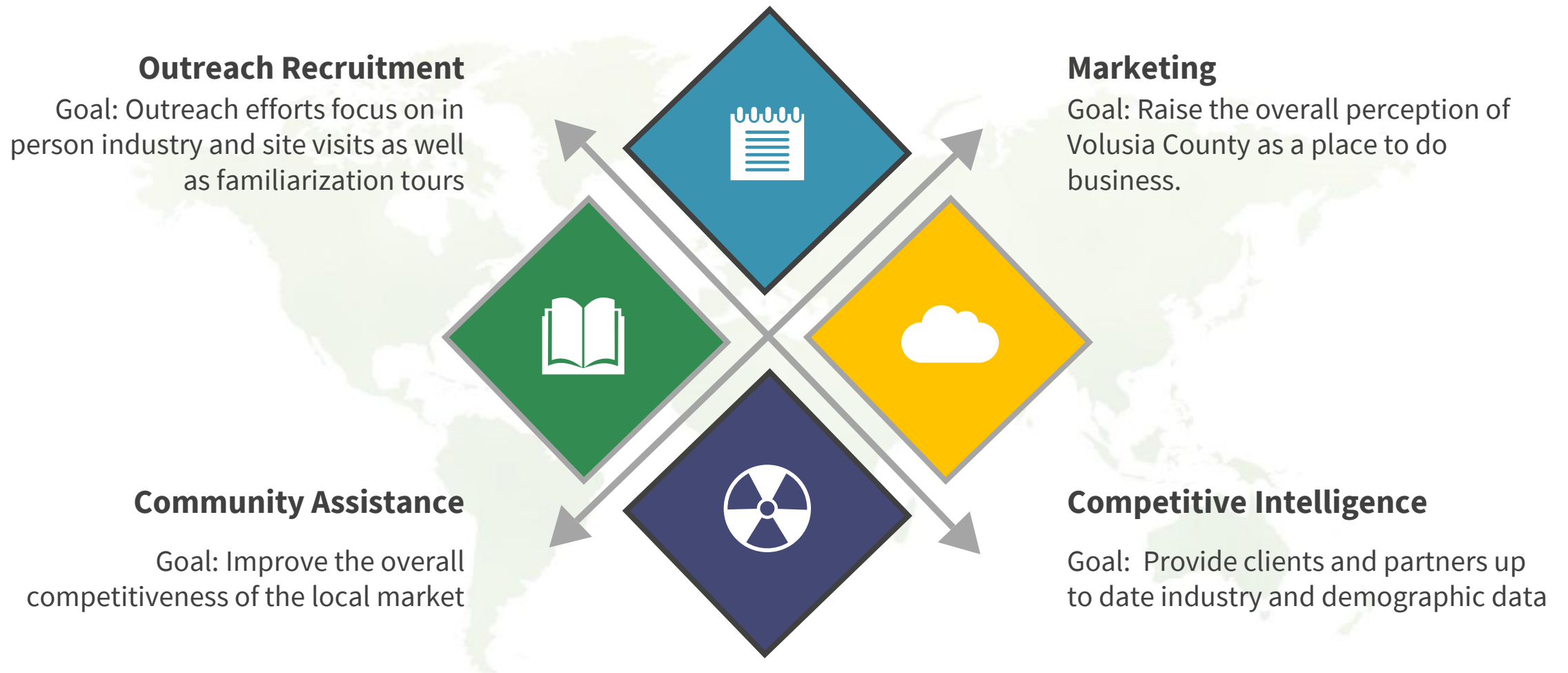

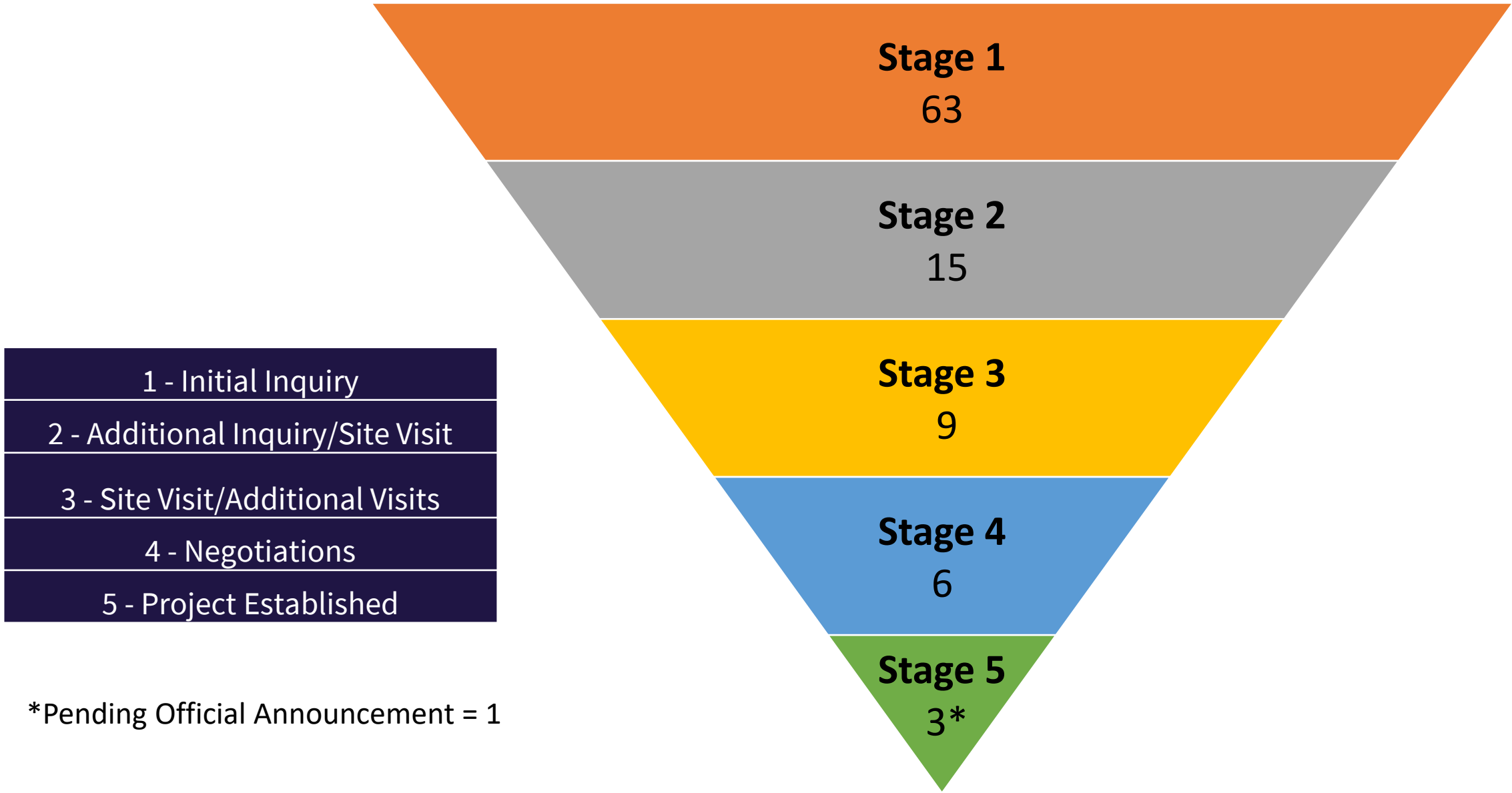

2022 Project Sales Funnel





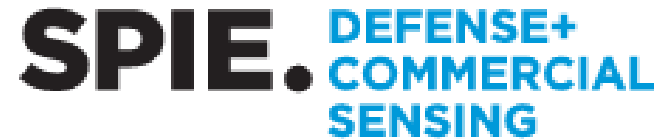

Total Number of Economic Development Outreach Meetings in May: 25

Florida Economic Development Council (FEDC)
TVEDC joined 240 attendees representing economic development organizations from across Florida at the 2022 FEDC Conference in St. Petersburg. Embracing this year's theme of "Capitalizing on Change," we participated in two days of forums and informative discussions about some of the biggest challenges and opportunities facing the future of economic development in our state, like the talent attraction pipeline, affordable housing, trade infrastructure, and industrial site readiness.

International Asset Management Council (IAMC) Spring Forum
IAMC is the leading trade association for corporate real estate executives focused on an industrial portfolio. Membership is limited to corporate end users, service providers and economic development organizations. Keith Norden, an IAMC Fellow, is a Charter Member, active since the organization's founding in 2002.
