**A RESOLUTION OF CITY OF DELTONA, FLORIDA;
CONFIRMING SUPPORT FOR THE ECHO GRANT
APPLICATION FOR THE KEYSVILLE PARK
IMPROVEMENTS PROJECT LOCATED AT 2641
KEYSVILLE AVENUE, DELTONA, FLORIDA 32725;
PROVIDING FOR TRANSMISSION, IMPLEMENTATION,
AND AN EFFECTIVE DATE.**

WHEREAS, In 2020, the voters of Volusia County approved the Volusia ECHO initiative which provides grants to not-for-profits, municipalities and county departments; and

WHEREAS, The program provides grant funds for projects that enhance the quality of life in Volusia County by insuring the availability of environmental, cultural, historical and outdoor recreational opportunities; and

WHEREAS, City staff has reviewed and prepared the grant application for the fiscal year 2026/2027; and

WHEREAS, the proposed project for the ECHO Application known as the Keysville Park Improvements which is located at 2641 Keysville Avenue; and.

WHEREAS, the total cost of the project is \$1,400,000, of which we are asking for \$700,000 in ECHO funds. The 1:1 match of \$700,000 is made up of unencumbered cash match; and

WHEREAS, should the total project costs exceed the budgeted amount, said funds shall be paid out of the unencumbered fund balance in the general fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. Echo Grant Keysville Park. That the City Commission hereby expresses its wholehearted support of the Echo Grant Application for the Keysville Park improvements project located at 2641 Keysville Avenue, Deltona, Florida 32725, Volusia County Florida.

Section 3. Transmission Authorized. That the City Clerk is hereby directed to transmit this Resolution and any other necessary supporting documents to the Volusia County Council and other local governments in Volusia County, Florida.

Section 4. Implementation. That the City Manager or his designee is hereby authorized to take any action which is necessary to implement this Resolution.

Section 5. Effective Date. This Resolution shall become effective immediately upon adoption.
