

**RESOLUTION NO. 2025-169**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA; ADOPTING A REVISED MASTER FEE SCHEDULE OF FINES, FEES, COSTS AND/OR PENALTIES AND VARIOUS ADMINISTRATIVE FEES RELATING TO THE CITY OF DELTONA CODE OF ORDINANCES; PROVIDING FOR CONFLICTS, SEVERABILITY, SCRIVENER'S ERRORS, AND AN EFFECTIVE DATE.**

**WHEREAS**, Article VIII of the State Constitution and Chapter 166, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal services, and may exercise any power for municipal purposes, except when expressly prohibited by law; and

**WHEREAS**, the City of Deltona, Florida (the "City") as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 166, Florida Statutes, is authorized and empowered to establish and consider changes to its fee schedule; and

**WHEREAS**, the City Commission hereby finds that due to labor, materials, and other expenditures, it is necessary for the City to impose certain fees; and

**WHEREAS**, from time-to-time circumstances and events may require the schedule of fines, fees, costs and / or penalties to be modified to reflect certain changes; and

**WHEREAS**, City staff conducted research regarding various fees charged for similar services by other municipalities including but not limited to building permits and inspections, fire permits and inspections, customer service and utility services, event permits, parks and recreations services, the center, planning, code enforcement, animal control, water, wastewater, capital service charges, and development review services; and

**WHEREAS**, City staff recommends that the City Commission consider adopting the revised master fee schedule, which is attached hereto and incorporated herein as Exhibit "A" (the "Master Fee Schedule"); and

**WHEREAS**, the City Commission of the City of Deltona, Florida, hereby finds this Resolution to be in the best interest of the public health, safety, and welfare of the citizens of Deltona.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISION OF THE CITY  
OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**Section 2. Fee Schedule Adopted.** The City Commission hereby approves and adopts the Master Fee Schedule, attached hereto and incorporated herein as Exhibit "A."

**Section 2. Conflicts.** All Resolutions or parts of Resolution insofar as they are inconsistent or in conflict with the provisions of this Resolution are hereby repealed to the extent of any conflict.

**Section 4. Severability.** In the event any portion of this Resolution is determined to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such decision shall in no manner affect the remaining portion or sections of the Resolution which shall remain in full force and effect.

**Section 5. Scrivener's Errors.** Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

**Section 6. Effective Date.** This Resolution shall become effective immediately upon its adoption.
