

RESOLUTION NO. 2026-07

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;
AUTHORIZING THE CITY MANAGER OR DESIGNEE TO
EXECUTE THE INTERLOCAL AGREEMENT WITH THE
COUNTY OF VOLUSIA TAX COLLECTOR FOR THE
UTILIZATION OF THE UNIFORM METHOD OF
COLLECTION OF THE NON-AD VALOREM
ASSESSMENTS; PROVIDING FOR IMPLEMENTATION
AND AN EFFECTIVE DATE.**

WHEREAS, public agencies, such as Counties and Cities, are permitted by Section 163.01(14), Florida Statutes, to engage in contracts for the performance of service functions of such public agencies; and

WHEREAS, the authorization for such agreements is granted to counties and cities for the purpose of permitting local governments to make the most efficient use of their powers by enabling them to cooperate with the other localities on a basis of mutual advantage and thereby to provide services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities as set for in 163.01(2), Florida Statutes; and

WHEREAS, the City of Deltona, Florida (the "City") previous entered into an Interlocal Agreement with the County of Volusia Property Appraiser for the Utilization of the Uniform Method of Collection of the Non-Ad Valorem Assessments; and

WHEREAS, the County of Volusia Tax Collector is now responsible for the duties described therein; and

WHEREAS, the City Commission of the City of Deltona, Florida has determined that it is in the best interest of its residents to enter into an Interlocal Agreement with the County of Volusia Tax Collector for the Utilization of the Uniform Method of Collection of the Non-Ad Valorem Assessments, which is attached hereto as Exhibit "A" (the "Interlocal"); and

WHEREAS, the City Commission desires to authorize the City Manager or designee to execute the Interlocal.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE
CITY OF DELTONA, FLORIDA:**

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. City Manager Authorized. That the City Manager or designee is authorized to execute the Interlocal Agreement with the County of Volusia Tax Collector for the Utilization of the Uniform Method of Collection of the Non-Ad Valorem Assessments in substantially the form attached as Exhibit "A," subject to any changes as may be deemed necessary by the City Attorney.

Section 3. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
