

RESOLUTION NO. 2026-13

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;
AUTHORIZING THE CITY MANAGER OR DESIGNEE TO
EXECUTE THE AGREEMENT WITH GEHRING GROUP,
INC. FOR BROKER/AGENT FOR INSURANCE
PROGRAMS SERVICES PURSUANT TO REQUEST FOR
PROPOSALS #26015; PROVIDING FOR
IMPLEMENTATION AND AN EFFECTIVE DATE.**

WHEREAS, the City of Deltona, Florida (the "City") issued Request for Proposals #26015, which is attached hereto and incorporated herein as Exhibit "A" (the "RFP") seeking qualified firms for the provisions of broker/agent for insurance programs services; and

WHEREAS, the Selection Committee has recommended Gehring Group, Inc. as the most responsive, responsible proposer to serve as agent of record for award of the RFP; and

WHEREAS, Gehring Group, Inc. has the resources and expertise to provide broker/agent insurance programs services; and

WHEREAS, the City Commission has determined it is in the best interest of the City to enter into an agreement with the Gehring Group, Inc. to ensure the provision of these essential services to the City, in accordance with the proposal attached hereto and incorporated herein as Exhibit "B" (the "Proposal"); and

WHEREAS, the City Commission desires to authorize the City Manager or designee to enter into an agreement with the Gehring Group, Inc. for broker/agent insurance programs services in accordance with the terms of the RFP and the Proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. City Manager Authorized. That the City Manager or designee is authorized to enter into an agreement with Gehring Group, Inc. for broker/agent insurance

programs services pursuant to RFQ#26015 in accordance with the terms of the RFP and the Proposal, subject to approval as to form and sufficiency as by the City Attorney.

Section 3. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
