A RESOLUTION OF CITY OF DELTONA, FLORIDA ADOPTING THE COMMUNITY DEVELOPMENT BLOCK **GRANT ANNUAL ACTION PLAN FOR FISCAL YEAR 2025-**2026: AUTHORIZING THE CITY MANAGER TO EXECUTE THE REQUIRED FEDERAL **FORMS** CERTIFICATIONS: AUTHORIZING SUBMITTAL OF THE PLAN TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT; PROVIDING FOR IMPLEMENTATION, CONFLICTS. AN AND EFFECTIVE DATE.

**WHEREAS**, the City of Deltona, Florida (the "City") receives entitlement Community Development Block Grant (CDBG) funding directly from the U.S. Department of Housing and Urban Development ("HUD"); and

**WHEREAS**, the City Commission of the City of Deltona desires to obtain federal CDBG funds and administer CDBG programs; and

WHEREAS, HUD requires all entitlement communities submit a Consolidated Plan every five years and an Annual Action Plan (AAP) annually to adhere to the requirements of applicable federal regulations; and

**WHEREAS,** in accordance with HUD guidelines, the City of Deltona has prepared the 2025-2026 AAP, that illustrates community needs and accepted uses of CDBG funds; and

**WHEREAS**, the APP also includes the federal application for funds and all required forms and certification to apply for funds from the federal CDBG program; and

**WHEREAS,** in Fiscal Year 2025-2026, the City will receive \$528,176.00 in CDBG funds; and

WHEREAS, City Staff has established a budget for the expenditure of CDBG funds; and

**WHEREAS**, the City Commission desires to adopt and authorize the submission of the Fiscal Year 2025-2026 AAP and provide for the implementation and administration of the AAP.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

**Section 1. Recitals Adopted.** That each of the above stated recitals is hereby adopted and confirmed.

**Section 2. Annual Action Plan Adopted.** That the Fiscal Year 2025-2026 Annual Action Plan, in substantially the form attached hereto as Exhibit "A," is hereby adopted.

Section 3. Transmission of Annual Action Plan and Execution of Required Forms Authorized. That the City Manager or his designee is hereby authorized to transmit the 2025-2026 AAP to HUD for its approval and execute the federal forms and certifications required.

**Section 4. Implementation.** That the City Manager or designee is hereby authorized to execute and submit all necessary documentation to HUD and to take any and all additional action necessary to implement the AAP and the purposes of this Resolution.

**Section 5.** Conflicts. All Resolutions, or parts of Resolution, insofar as they are inconsistent or in conflict with the provisions of this Resolution are hereby repealed to the extent of any conflict.

**Section 6. Effective Date.** This Resolution shall become effective immediately upon its passage and adoption by the City Commission.

# NOTICE OF 30-DAY PUBLIC COMMENT PERIOD AND PUBLIC HEARING FOR ONE YEAR ANNUAL ACTION PLAN (PY 2025-2026) ONE YEAR (DRAFT) AND PRIOR YEAR AMENDMENT

To ALL INTERESTED RESIDENTS AGENCIES AND ORGANIZATIONS: The City of Deltona is publishing this draft to the 2025-2026 Annual Action Plan (AAP) for the Community Development Block Grant (CDBG) Program. The Department of Housing and Urban Development (HUD) has proposed to allocate \$528,176. to the City of Deltona for the Community Development Block Grant Program for Program Year (PY) 2025 which covers the period, October 1,2025 through September 30, 2026. The AAP identifies proposed projects and or activities to be undertaken with CDBG funds for the coming year which will serve to benefit low to moderate income persons. Listed below are the proposed projects and activities estimated to be implemented in the coming year. The City is also amending the prior year 2024-2025 AAP for funds remaining after the proposed 2024-2025 projects were not completed or cancelled.

The City was required to submit a Five- Year Consolidated Plan (Con Plan) to address housing, non-housing, and community development needs projected over the period PY 2023-2027. The Consolidated Plan was submitted in the 2023-2024 (PY) and included a Strategic Plan to identify housing and community development needs that provided options to develop priorities and objectives that may address those needs. The third Annual Action Plan from the five-year 2023-2028 Consolidated Plan period will be the 2025-2026 Annual Action Plan.
