

RESOLUTION NO. 2025-156

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;
AUTHORIZING THE CITY MANAGER OR DESIGNEE TO
EXECUTE THE AGREEMENT WITH HALIFAX HUMANE
SOCIETY, INC. FOR AS-NEEDED ANIMAL SHELTERING
SERVICES; PROVIDING FOR IMPLEMENTATION AND AN
EFFECTIVE DATE.**

WHEREAS, the City of Deltona (the “City”) recognizes the need to provide humane animal sheltering for the protection and welfare of the community and its animals; and

WHEREAS, the provision of humane animal sheltering and related services is a specialized and unique service exempt from competitive bidding pursuant to the City’s Purchasing Policies; and

WHEREAS, Halifax Humane Society, Inc. (“Halifax”) has the resources and expertise to provide animal sheltering and related services in a professional and compassionate manner; and

WHEREAS, it is in the best interest of the City and its residents to enter into an agreement with Halifax to ensure the provision of these essential services to the City, which is attached hereto as Exhibit “A” (the “Agreement”); and

WHEREAS, the City Commission desires to authorize the City Manager or designee to execute the Agreement with Halifax for animal sheltering and related services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. City Manager Authorized. That the City Manager or designee is authorized to execute the Agreement with Halifax Humane Society, Inc for Animal sheltering and related services in substantially the form attached as Exhibit “A” (the “Agreement”),

subject to any changes to form or sufficiency as may be deemed necessary by the City Attorney.

Section 3. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
