A RESOLUTION OF THE CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO AMEND THE WORK AUTHORIZATION WITH PEGASUS ENGINEERING, LLC, FOR AS-NEEDED STORMWATER ENGINEERING SERVICES PURSUANT TO RFQ PW-2020-08 CONTINUING ON-CALL STORMWATER ENGINEERING SERVICES; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, the City of Deltona, Florida (the "City") issued RFQ No. PW-2020-08 Continuing On-Call Stormwater Engineering Services (the "RFQ") in order to create a pool of consultants available to the City for various on-call stormwater engineering services; and

WHEREAS, Pegasus Engineering, LLC (the "Consultant") was awarded a continuing contract with the City pursuant to the RFQ (the "Continuing Contract"); and

WHEREAS, the City issued a work authorization to the Consultant for as-needed stormwater engineering services in an amount not to exceed one hundred seventy four thousand four hundred and forty four dollars and fifty four cents (\$174,444.54) (the "Work Authorization"); and

WHEREAS, the Consultant has been vital to the City by reviewing stormwater projects, building permits, site plan reviews, peer reviews, Community Ranking System, NPDES program, FEMA Flood Plain Review, and SJRWMD submissions on behalf of the City; and

WHEREAS, due to the volume of required reviews, additional funds are necessary for the Consultant to continue providing as-needed services under the Work Authorization; and

WHEREAS, the City Commission desires to amend the Work Authorization to a total amount not to exceed three hundred thousand dollars (\$300,000.00).
