

RESOLUTION NO. 2025-161

**A RESOLUTION OF THE CITY OF DELTONA, FLORIDA;
AUTHORIZING THE REALLOCATION OF UNEXPENDED
COMMUNITY DEVELOPMENT BLOCK GRANT CARES
ACT (CDBG-CARES) PROGRAM FUNDS FROM THE U.S.
DEPARTMENT OF HOUSING AND URBAN
DEVELOPMENT (HUD) GRANT #B-20-MW-120049 FOR
THE PURCHASE OF A PREVIOUSLY APPROVED
AMBULANCE FOR FIRE STATION 61; PROVIDING FOR
IMPLEMENTATION AND AN EFFECTIVE DATE.**

WHEREAS, Volusia County (the “County”) received Community Development Block Grant Coronavirus Response (“CDBG-CV”) funds, now part of the Community Development Block Grant CARES Act (CDBG-CARES) program funds from the U.S. Department of Housing and Urban Development (“HUD”) Grant #B-20-MW-120049; and

WHEREAS, the City of Deltona (the “City”) received an allocation of three million two hundred and twenty seven thousand seven hundred and thirty dollars (\$3,227,730.00) through HUD Grant #B-20-MW-120049; and

WHEREAS, three hundred and eighteen thousand nine hundred and forty one dollars and seventy six dollars and seventy six cents (\$318,941.76) of HUD Grant #B-20-MW-120049 remain unexpended; and

WHEREAS, on October 21, 2024, the City Commission approved the purchase of a 2024 Frazer International Ambulance with a Frazer Ambulance Quote #Q3980-001 in the amount of four hundred eighty-one thousand five hundred and forty-one dollars and zero cents (\$481,541.00); and

WHEREAS, the City’s authorized Frazer Ambulance purchase for Fire Station 61 is an eligible expenditure and meets the intent of meets the intent of the CDBG-CARES program by improving emergency medical response and supporting public health and safety services for the community; and

WHEREAS, vehicle will primarily serve low and moderate income (LMI) areas within the City, consistent with HUD’s national objectives for the CDBG-CARES program; and

WHEREAS, the City Commission desires to authorize the reallocation of the unexpended funds under HUD Grant #B-20-MW-12-0049, towards the Frazer Ambulance

purchase for Fire Station 61 with a total anticipated purchase budget of four hundred eighty-one thousand five hundred and forty-one dollars and zero cents (\$481,541.00) with three hundred eighteen thousand nine hundred forty-one and seventy-six cents (\$318,941.76) to come from HUD Grant #B-20-MW-12-0049 and the remaining one hundred sixty-two thousand five hundred and ninety-nine dollars and twenty-four cents (\$162,599.24) to be funded by the City of Deltona utilizing previously allocated funds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. Reallocation of CDBG-CARES Funds Authorized. That the reallocation of the unexpended funds under HUD Grant #B-20-MW-12-0049, towards the Frazer Ambulance purchase for Fire Station 61 with a total anticipated purchase budget of four hundred eighty-one thousand five hundred and forty-one dollars and zero cents (\$481,541.00) with three hundred eighteen thousand nine hundred forty-one and seventy-six cents (\$318,941.76) to come from HUD Grant #B-20-MW-12-0049 and the remaining one hundred sixty-two thousand five hundred and ninety-nine dollars and twenty-four cents (\$162,599.24) to be funded by the City of Deltona utilizing previously allocated funds is hereby authorized.

Section 3. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
