

RESOLUTION NO. 2026-64

A RESOLUTION OF THE CITY OF DELTONA, FLORIDA; APPROVING THE SETTLEMENT OF ALL CLAIMS MADE BY LINETTE QUINTANA AND RADAMES ESTRADA ; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, on or about September 25, 2024, Radames Estrada was operating a motor vehicle which was also occupied by Linette Quintana traveling East on Saxon Blvd., Deltona, Florida and a City Employee driving a City vehicle collided with their vehicle (the "Accident"); and

WHEREAS, it is alleged that, Linette Quintana and Radames Estrada suffered personal injuries and incurred medical expenses as a result of the Accident; and

WHEREAS, as a result of the Accident, Linette Quintana and Radames Estrada, filed a lawsuit against the City of Deltona ("City") in Florida's 7th Judicial Circuit in and for Volusia County, styled as *Linette Quintana and Radames Estrada v. City of Deltona* and identified by Case Number 2025-13100-CIDL (the "Litigation"); and

WHEREAS, Linette Quintana and Radames Estrada have each agreed to execute a General Release extinguishing any and all claims including all past, present, and future claims for damages arising from the Accident for the total amount of sixty thousand dollars (\$60,000.00), including all costs and attorney's fees (the "Settlement Amount"); and

WHEREAS, the City desires to avoid the uncertainties and expense of litigation; and

WHEREAS, the City's insurance carrier for the Accident and Litigation, PGCS, will cover the cost of the Settlement Amount and the City has no deductible for this claim; and

WHEREAS, the City Commission has determined that it is in the best interest of the City to extinguish all claims raised by Linette Quintana and Radames Estrada arising from the Accident in consideration of the Settlement Amount.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. Settlement Agreement Approved. That the City Commission approves the settlement of all claims that were or could have been asserted by Linette Quintana and Radames Estrada which arise or relate to the Accident, inclusive of costs and

attorney's fees for the Settlement Amount, subject to the receipt of a full and unconditional Release by Quintana and Radames as approved by the City Attorney.

Section 3. Implementation. That the City Manager or his designee is hereby authorized to execute all documents and agreements, in a form approved by the City Attorney, necessary to implement the intent of this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
