

## RESOLUTION NO. 2025-115

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;  
AUTHORIZING THE CITY MANAGER TO AWARD AN  
AGREEMENT TO REDMAN CONSULTING GROUP, INC,  
FOR WASTE PRO CONTRACT MANAGEMENT TO THE  
SOLID WASTE DEPARTMENT; RECOGNIZING AN  
EXEMPTION TO COMPETITIVE BIDDING; PROVIDING  
FOR IMPLEMENTATION AND AN EFFECTIVE DATE.**

**WHEREAS**, on October 1, 2018, the City Commission of the City of Deltona directed the City Manager to authorize the services for solid waste contract management for Waste Pro utilizing the services of Redman Consulting Group, Inc.; and

**WHEREAS**, City Commission shall provide as part of the Fiscal Year 2025-2026 funding for the services provided by Redman Consulting Group, Inc.; and

**WHEREAS**, the City of Deltona Purchasing Policy provides for an exemption from competitive bidding for financial and consulting services; and

**WHEREAS**, Redman Consulting Group, Inc. (the "Vendor") is a qualified company to provide the professional financial and consulting services required to conduct the Fire Assessment Study (the "Services"); and

**WHEREAS**, the Vendor submitted a proposal to the City of Deltona to provide the Services for a total amount not to exceed ninety-one thousand five hundred dollars (\$91,500.00) for the first two years, which is attached hereto and incorporated herein as Exhibit "A" (the "Proposal"); and

**WHEREAS**, the City Commission desires to authorize the City Manager or his designee to execute an agreement with the Vendor to perform the Services in accordance with the Proposal; and

**WHEREAS**, the City Commission recognizes that additional funding will be required in the future years to complete the Services; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. City Manager Authorized.** That the City Manager is authorized to execute an agreement with Redman Consulting Group, Inc. to complete the residential and commercial contract management in an amount not to exceed ninety-one thousand five hundred dollars (\$91,500.00) annually for the first two years to be provided in

accordance with City Budgets and without requiring further consideration by the City Commission.

**Section 3. Exemption from Competitive Bidding.** That the City Commission recognizes an exemption from competitive bidding pursuant to City Purchasing Policy, which provides that financial and consulting services may be considered exempt from competitive bidding.

**Section 4. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 5. Effective Date.** That this Resolution shall become effective immediately upon its adoption.
