**WHEREAS,** the City of Deltona, Florida (the "City") is an entitlement community and receives funds from the Florida Housing Finance Corporation State Housing Initiatives Partnership (SHIP) program; and

**WHEREAS**, the City administers a SHIP-approved program known as the Owner Occupied Rehabilitation ("OOR") Program to assist income-qualified residents with home repairs; and

WHEREAS, the City has recommended OOR Program awards not to exceed sixty thousand dollars (\$60,000) for each of two properties located within the City of Deltona City Limits at 2481 Newmark Drive, and 1004 Fountainhead Drive (the "OOR Properties"); and

**WHEREAS**, the City issued RFP #23014 to establish a pre-qualified list of General Contract for as-needed construction services; and

**WHEREAS,** Parthy, LLC was deemed a qualified and competent respondent to RFP #23014; and

WHEREAS, pursuant to RFP #23014, the City entered into the Master Agreement Between City of Deltona and Parthy, LLC (the "Parthy Master Agreement") for as-needed construction services on June 2, 2023; and

**WHEREAS**, the Contractor submitted proposals to perform the work needed at 2481 Newmark Drive, and 1004 Fountainhead Drive (the "Parthy Services"), as described in Exhibit "A" (the "Parthy Proposals"); and

**WHEREAS**, the City Commission desires to approve the Parthy Proposal and in an amount not to exceed sixty thousand dollars (\$60,000) for each property.

Purchase Approved.** That the Parthy Proposals, in substantially the form which is attached hereto, are approved, and the City Manager or his designee is authorized to accept the Parthy Proposals, and execute and implement the Work Authorization for the performance of the Parthy Services, once approved by the City Attorney as to form and legal sufficiency.

**Section 4. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement the purpose of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.
