

RESOLUTION NO. 2026-67

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;
AUTHORIZING THE CITY MANAGER OR DESIGNEE TO
EXECUTE MULTIPLE CONTRACTS FOR AS-NEEDED
MISCELLANEOUS LAND ACQUISITION SERVICES; ON A
CONTINGENCY BASIS; PURSUANT TO INVITATION TO
BID # 26019; ESTABLISHING A ROTATING VENDOR LIST;
PROVIDING FOR PROCUREMENT CONSISTENCY WITH
THE CITY'S PURCHASING POLICY PROVIDING FOR
IMPLEMENTATION AND AN EFFECTIVE DATE.**

WHEREAS, the City of Deltona, Florida (the "City") issued Invitation to Bid #26019, which is attached hereto and incorporated herein as Exhibit "A" (the "ITB") seeking qualified contractors for miscellaneous land Acquisition Services; and

WHEREAS, such services are intended to be utilized on a contingency basis for emergency work and other operational needs; and

WHEREAS, the City desires to establish a rotating list of qualified vendors, without designation of primary or secondary vendors, for the efficient delivery of such services; and

WHEREAS, all non-emergency work exceeding Five Thousand Dollars (\$5,000.00) shall be procured in accordance with the City's Purchasing Policy, including applicable quotation requirements; and

WHEREAS, the City Commission finds that it is in the best interest of the City to authorize the City Manager or designee to award and administer such as-needed contracts consistent with the results of the competitive solicitations.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE
CITY OF DELTONA, FLORIDA:**

Section 1. Recitals Adopted.

The foregoing recitals are hereby ratified and confirmed as true and correct and are incorporated herein.

Section 2. Authorization of As-Needed Services Contracts.

The City Manager or designee is hereby authorized to award contracts and issue purchase orders for as-needed miscellaneous land acquisition services on a contingency basis for emergency work, and other operational needs, utilizing a rotating list of qualified vendors, without designation of primary or secondary vendors, as follows:

MISCELLANEOUS LAND ACQUISITION SERVICES (BID#26019)

AMERICAN ACQUISITION GROUP, LLC.

BOWMAN CONSULTING GROUP, LTD.

O.R.S. COLAN ASSOCIATES, LLC.

Section 3. Procurement Requirements.

All non-emergency work in excess of Five Thousand Dollars (\$5,000.00) shall be procured in accordance with the City's Purchasing Policy, including applicable quotation or competitive requirements.

Section 4. Implementation.

The City Manager is authorized to take all actions necessary to implement this Resolution, including execution of any documents consistent herewith.

Section 5. Conflicts.

All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section 6. Severability.

If any section, subsection, sentence, clause, or provision of this Resolution is held invalid, the remainder shall not be affected and shall remain in full force and effect.

Section 7. Effective Date.

This Resolution shall become effective immediately upon adoption.
