

## RESOLUTION NO. 2025-78

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;  
AUTHORIZING THE CITY MANAGER AND/OR DESIGNEE  
TO EXECUTE THE VOLUSIA-FLAGLER  
TRANSPORTATION PLANNING ORGANIZATION FISCAL  
YEAR 2025-2026 FUNDING AGREEMENT; AUTHORIZING  
EXECUTION OF SUBSEQUENT ANNUAL AGREEMENTS  
IN ACCORDANCE WITH CITY BUDGETS; PROVIDING  
FOR IMPLEMENTATION AND AN EFFECTIVE DATE.**

**WHEREAS**, Section 134 of Title 23 of the United States Code and Section 339.175, Florida Statutes requires designation of a metropolitan planning organization (“MPO”) in urbanized areas, as defined by the US Bureau of Census; and

**WHEREAS**, the Volusia-Flagler Transportation Planning Organization (the “TPO”) serves as the MPO for the Volusia and Flagler Urbanized Areas, of which the City of Deltona (the “City”) is a member, and is the agency designated to conduct a continuing, coordinated, and comprehensive transportation planning process; and

**WHEREAS**, Section 339.175, Florida Statutes describes the membership of the MPO, including the authority of the Governor to apportion membership based on agreement with local governments, geographic location and equitable population distribution; and

**WHEREAS**, the TPO has submitted its annual Funding Agreement for Fiscal Year 2025-2026 (the “Agreement”) to the City for the total amount of nine thousand seven hundred and thirty four dollars (\$9,734.00) to be contributed by the City; and

**WHEREAS**, the City of Deltona desires to remain a member of the Volusia-Flagler Transportation Planning Organization and provide its proportional share of funding based on population; and

**WHEREAS**, the City Commission desires to authorize the City Manager or his designee to execute the Agreement; and

**WHEREAS**, the City Commission further desires to authorize the City Manager or his designee to execute any subsequent annual funding agreements for the TPO in accordance with City Budgets.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Agreement Authorized.** That the City Manager and/or his designee is authorized to execute the Volusia-Flagler Transportation Planning Organization Funding Agreement for Fiscal Year 2025-2026.

**Section 3. Annual Agreements Authorized.** That the City Manager and/or his designee is authorized to execute subsequent annual funding agreements in accordance with City Budgets.

**Section 4. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 5. Effective Date.** That this Resolution shall become effective immediately upon its adoption.
