## **RESOLUTION NO. 2025-87**

## A RESOLUTION OF CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER TO AWARD AN AGREEMENT TO ALFRED BENESCH & COMPANY FOR FIRE RESCUE ASSESSMENT STUDY RELATED TO THE DELTONA FIRE DEPARTMENT; RECOGNIZING AN EXEMPTION TO COMPETITIVE BIDDING; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

**WHEREAS**, on May 3, 2025, the City Commission of the City of Deltona directed the City Manager to conduct study regarding the implementation of a fire assessment program (the "Fire Assessment Study"); and

WHEREAS, City Commission approved Resolution No. 2025-52 which provided funding in an amount of fifty nine thousand five hundred dollars (\$59,500.00) to fund the Fire Assessment Study; and

**WHEREAS**, the City of Deltona Purchasing Policy provides for an exemption from competitive bidding for financial and consulting services; and

WHEREAS, Alfred Benesch & Company (the "Vendor") is a qualified company to provide the professional financial and consulting services required to conduct the Fire Assessment Study (the "Services"); and

WHEREAS, the Vendor submitted a proposal to the City of Deltona to provide the Services in five (5) distinct tasks for a total amount not to exceed eighty two thousand five hundred and fifteen dollars (\$82,515.00), which is attached hereto and incorporated herein as Exhibit "A" (the "Proposal"); and

WHEREAS, the City Commission desires to authorize the City Manager or his designee to execute an agreement with the Vendor to perform the Services in accordance with the Proposal; and

WHEREAS, the City Commission recognizes that additional funding will be required in the future complete the Services; and

WHEREAS, the City Commission desires to provide for each task under the Vendor's Proposal to be authorized by the City Manager in accordance with City Budgets, commencing with Phase 1: Technical Calculation in an amount not to exceed forty seven thousand three hundred fifteen dollars (\$47,315.00).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted,

confirmed, and incorporated herein.

Section 2. City Manager Authorized. That the City Manager is authorized to execute an agreement with Alfred Benesch & Company to complete the Fire Assessment Study in an amount not to exceed eighty two thousand five hundred and fifteen dollars (\$82,515.00) with each of the five (5) tasks in the Proposal to require prior written authorization by the City Manager to be provided in accordance with City Budgets and without requiring further consideration by the City Commission.

Section 3. **Exemption from Competitive Bidding.** That the City Commission recognizes an exemption from competitive bidding pursuant to City Purchasing Policy, which provides that financial and consulting services may be considered exempt from competitive bidding.

**Section 4.** Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 5. Effective Date. That this Resolution shall become effective immediately upon its adoption.
