

**RESOLUTION NO. 2026-08**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY  
OF DELTONA, FLORIDA; RATIFYING ACTIONS OF THE CITY  
MANAGER AND/OR DESIGNEE RELATED TO WAIVER OF  
SERVICE DISCONNECTIONS FOR NON-PAYMENT AND  
LATE PAYMENT FEES IMPOSED PURSUANT TO SECTION  
68-60 OF THE CITY OF DELTONA CODE OF ORDINANCES  
AND MASTER FEE RESOLUTION NO. 2025-169; PROVIDING  
FOR IMPLEMENTATION AND AN EFFECTIVE DATE.**

**WHEREAS**, the City of Deltona, Florida (the "City") owns and operates a water and wastewater utility; and

**WHEREAS**, fees for non-payment and late payment for water and wastewater services are imposed pursuant to the City of Deltona Code of Ordinances Section 68-60 and Resolution No. 2025-140; and

**WHEREAS**, the City is further authorized to disconnect services for non-payment of fees due for water and wastewater services; and

**WHEREAS**, on December 29, 2025, the City's online bill payment system began to experience an extended outage due to a third-party vendor software issue; and

**WHEREAS**, due to the extended outage, the City Manager and/or designee deemed it appropriate to waive all late payment fees from December 26, 2025, through January 23, 2026; and

**WHEREAS**, due to the extended outage, the City Manager and/or designee further deemed it appropriate to suspend all disconnections for non-payment from December 29, 2025, through January 12, 2026; and

**WHEREAS**, the City Commission deems it appropriate and in the best interest of the public health, safety, and welfare of the citizens of Deltona to ratify the foregoing actions of the City Manager and/or his designee.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY  
OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**Section 2. Ratification.** The City Commission hereby ratifies the actions of the City Manager and/or designee as it relates to the waiver of all late payment fees related to water and wastewater services from December 26, 2025, through January 23, 2026, and the suspension of all service disconnections for non-payment from December 29, 2025, through January 12, 2026.

**Section 3. Implementation.** The City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 6. Effective Date.** This Resolution shall become effective immediately upon its adoption.
