

RESOLUTION NO. 2026-16

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;
AUTHORIZING THE MAYOR TO EXECUTE THE FIRST
AMENDMENT TO INTERLOCAL AGREEMENT FOR
SUPPLEMENTAL OPERATIONAL ASSISTANCE AND
VOLUNTARY COOPERATION FOR ANIMAL CONTROL
SERVICES; PROVIDING FOR RECORDING,
IMPLEMENTATION AND AN EFFECTIVE DATE.**

WHEREAS, the County of Volusia, Florida (the “County”) and the City of Deltona, Florida (the “City”) are authorized pursuant to Section 163.01, Florida Statutes to enter into agreements to make the most efficient use of their powers and cooperate on a basis of mutual advantage and thereby provide services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities; and

WHEREAS, the County and the City entered into an Interlocal Agreement for Supplemental Operational Assistance and Voluntary Cooperation on July 22, 2020, (the “Agreement”) for the initial term through July 22, 2025, with an additional five-year term through July 22, 2030; and

WHEREAS, the City and County desire to cooperate in animal control services, which permits voluntary cooperation and assistance in emergency situations and providing assistance for the purpose of animal search and rescue as well as pet sheltering for animal cruelty, animal fighting, dangerous dogs, and impoundment of animals found in distress; and

WHEREAS, the City and County find it necessary to make changes to the Agreement’s terms related to sheltering and rendering assistance in emergency situations; and

WHEREAS, the City Commission finds it is in the best interest of the City and its residents to enter into the First Amendment to Interlocal Agreement for Supplemental Operational Assistance and Voluntary Cooperation with the County to ensure the provision

of essential services to the City, in substantially the form attached hereto and incorporated herein as Exhibit “A,” subject to changes as to form and sufficiency as may be required by the City Attorney (the “Amendment”); and

WHEREAS, the City Commission desires to authorize the Mayor to execute the Amendment.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. First Amendment to Interlocal Agreement Approved. That the City Commission hereby approves the First Amendment to Interlocal Agreement for Supplemental Operational Assistance and Voluntary Cooperation with Volusia County and authorizes the Mayor to execute the Amendment substantially the form attached hereto as Exhibit “A,” subject to any changes to form or sufficiency as may be deemed necessary by the City Attorney.

Section 3. Recording. That the Amendment shall be recorded in the Public Records of Volusia County, Florida in the manner required by law.

Section 4. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 5. Effective Date. That this Resolution shall become effective immediately upon its adoption.
