

RESOLUTION NO. 2025-51

A RESOLUTION OF CITY OF DELTONA, FLORIDA ACTIVATING THE ORDINANCE REVIEW COMMITTEE; PROVIDING FOR CONFLICTS, IMPLEMENTATION, SUNSET, AND AN EFFECTIVE DATE.

WHEREAS, the City Commission desires to activate the Ordinance Review Committee provided for in Section 1-17 of the Code of Ordinances (the "Committee") for the purpose of engaging in a comprehensive review of the Code of Ordinances of the City of Deltona (the "City"); and

WHEREAS, the City Commission has directed the City Manager to engage with a professional consultant to facilitate the review of the City's Code of Ordinances and prepare proposed revisions for consideration by the City Commission; and

WHEREAS, the Committee can play a vital role to empower local residents, encourage active participation, and create a platform for collective decision-making and action; and

WHEREAS, the City Commission has directed the City Manager and City Attorney to work closely with the Committee and a professional consultant to prepare revisions to the Code of Ordinances; and

WHEREAS, the City Commission finds that the activation of the Committee as provided herein is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals. The above recitals are hereby adopted and confirmed.

Section 2. Ordinance Review Committee Activated. The City Commission hereby activates the Ordinance Review Committee provided for in Section 1-17 of the Code of Ordinances (the "Committee") for the purpose of engaging in a comprehensive review of the Code of Ordinances of the City of Deltona.

Section 3. Member Composition. The Committee shall be comprised of seven persons, with the Mayor and each City Commission Member appointing one person. The members of the Committee will each be either a resident of the City or be involved in a business or other organization in the City. Notwithstanding provisions for the sunset of the Committee, each member shall serve a two year term, and members can succeed themselves in office.

Section 4. Jurisdiction. The purpose of the Committee is to advise the City

Commission on a comprehensive review of the City's Code of Ordinances while working in collaboration with the City Manager, City Attorney, and professional consultant. The recommendations of the Committee are purely advisory in nature and are not binding on the City.

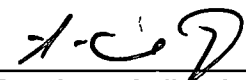
Section 5. Conflicts. All Resolutions or parts of Resolution insofar as they are inconsistent or in conflict with the provisions of this Resolution are hereby repealed to the extent of any conflict.

Section 6. Implementation. That the City Manager is hereby authorized to take any and all action necessary to effectuate the intent of this Resolution.

Section 7. Sunset. The Board shall automatically sunset and be dissolved 12 months from October 1, 2025, unless the life of the Board is extended by Resolution of the City Commission.

Section 8. Effective Date. This Resolution shall become effective immediately upon its adoption.

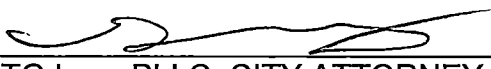
