

## RESOLUTION NO. 2025-108

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;  
AUTHORIZING THE CITY MANAGER OR DESIGNEE TO  
AMEND THE PURCHASE ORDER FOR HUBER  
TECHNOLOGY, INC.; RECOGNIZING AN EXEMPTION  
FROM COMPETITIVE BIDDING; PROVIDING FOR  
AMENDMENTS AND RENEWALS IN ACCORDANCE WITH  
CITY BUDGETS; PROVIDING FOR IMPLEMENTATION  
AND AN EFFECTIVE DATE.**

**WHEREAS**, the City of Deltona, Florida (the “City”) Purchasing Policy provides for Sole Source purchases, meaning a purchase where a good or service is available from only one supplier, as an exemption from competitive bidding; and

**WHEREAS**, Huber Technology Inc. (the “Vendor”) provides repairs and parts for the Huber screw press and associated equipment located at the Eastern Wastewater Treatment Facility (the “Equipment”) pursuant to a Sole Source Authorization; and

**WHEREAS**, the Equipment is a critical part of the wastewater treatment process and must remain operating correctly to process waste sludge and its malfunction can result in additional costs to the City in the form of increased sludge hauling fees; and

**WHEREAS**, the Vendor performed routine maintenance on the Equipment during the month of May 2025 pursuant to a Purchase Order issued for twenty five thousand dollars (\$25,000.00); and

**WHEREAS**, upon inspection, it was determined that additional parts and labor were required to ensure the correct and efficient operation of the Equipment (the “Additional Work”); and

**WHEREAS**, an additional ten thousand nine hundred thirty dollars and sixty nine cents (\$10,930.69) is needed for the Additional Work; and

**WHEREAS**, the City Commission desires to authorize the City Manager or his designee to amend the Purchase Order with the Vendor to an amount not to exceed thirty five thousand nine hundred thirty dollars and sixty nine cents (\$35,930.69); and

**WHEREAS**, the City Commission further desires to authorize the City Manager or his designee to award subsequent purchase orders and amendments on an annual basis to the Vendor that are in accordance with City Budgets.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Purchase Approved.** That the City Manager or his designee is authorized to amend the Purchase Order 250261 with Huber Technology, Inc., issued pursuant to a Sole Source Authorization, from twenty five thousand dollars (\$25,000.00) to thirty five thousand nine hundred thirty dollars and sixty nine cents (\$35,930.69).

**Section 3. Renewals and Purchase Orders Authorized.** That the City Manager or his designee is authorized to award purchase orders and amendments thereto on an annual basis in accordance with City Budgets.

**Section 4. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 5. Effective Date.** That this Resolution shall become effective immediately upon its adoption.
