

RESOLUTION NO. 2025-130

A RESOLUTION OF THE CITY OF DELTONA, FLORIDA; ADOPTING THE 2025 VOLUSIA COUNTY LOCAL MITIGATION STRATEGY PLAN; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, the City of Deltona, Florida (the “City”) is vulnerable to an array of natural hazards that can cause the loss of life and damage to public and private property; and

WHEREAS, the City desires to seek ways to mitigate situations that may aggravate such circumstances; and

WHEREAS, the development and implementation of a local mitigation strategy can result in actions that reduce the long-term risk to life and property from natural hazards; and

WHEREAS, it is the intent of the City Commission to protect its citizens and property from the effects of natural hazards by preparing and maintaining a local mitigation strategy; and

WHEREAS, it is also the intent of the City Commission to fulfill its obligation under Section 322: Mitigation Planning, of the Robert T. Stafford Disaster Relief and Emergency Assistance Act to remain eligible to receive certain types of federal assistance in the event of a declared disaster affecting the City of Deltona; and

WHEREAS, Volusia County originally facilitated the development of a multi-jurisdictional local mitigation strategy that includes the City of Deltona in the year 2000 with input from the appropriate local and state officials; and

WHEREAS, Volusia County facilitated the update of the multi-jurisdictional local mitigation strategy in 2009 that includes the City of Deltona with input from the appropriate local and state officials; and

WHEREAS, Volusia County facilitated the update of the multi-jurisdictional local mitigation strategy in 2020 that includes the City of Deltona with input from the appropriate local and state officials; and

WHEREAS, the Florida Division of Emergency Management and the Federal Emergency Agency have revised the updated local mitigation strategy

prepared for the City of Deltona for legislative compliance and has approved the plan pending the completion of local adoption procedures; and

WHEREAS, the City Commission desires to adopt the 2025 Volusia County Local Mitigation Strategy Plan, which is attached hereto and incorporated herein as Exhibit “A” (the “LMS”).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That the above recital is hereby adopted, confirmed, and incorporated herein.

Section 2. 2025 Volusia County Local Mitigation Strategy Plan Adopted. That the 2025 Volusia County Local Mitigation Strategy Plan, which is attached hereto and incorporated herein as Exhibit “A” (the “LMS”), is hereby adopted.

Section 3. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
