### **E.** Engagement Activities

Six engagement activities will be available to workshop participants. Each station will be facilitated by both a member of City Staff and the Consulting Team. These activities are described as follows:

- 1. <u>Exploring Alternative Housing Choices</u>. Participants identify which housing types they think would be a good fit for Deltona by placing a dot on their preferred options.
- 2. <u>Targeted Industry Survey</u>. Participants identify which industries the city should target next.
- 3. <u>Targeted Industry Incentives</u>. Participants select which targeted industry incentives are most appropriate for the city.

- 4. What Should Be in a "Mixed-Use Neighborhood?" Participants identify the types of uses they would like to see permitted within a mixed-use neighborhood.
- 5. What Does Mixed Use Look Like Next to a Neighborhood? Participants identify the building, parking, sidewalk, and buffering standards they think best support Deltona Vision 2050's mixed-use guiding principle while maintaining compatibility with nearby neighborhoods.
- 6. What Does Mixed Use Look Like in a Major Activity Center? Participants identify the building, parking, sidewalk, and buffering standards they think best support Deltona Vision 2050's mixed-use guiding principle while maintaining compatibility with surrounding developments.
