RESOLUTION NO. 2025-131

A RESOLUTION OF CITY OF DELTONA, FLORIDA; **AUTHORIZING THE CITY MANAGER OR DESIGNEE TO** ISSUE PURCHASE ORDERS TO ATLANTIC PIPE SERVICES, LLC FOR PIPE LINING PURSUANT TO A PIGGYBACK OF **VOLUISA** COUNTY MASTER AGREEMENTS MA 12439-1 AND 12503-2; PROVIDING FOR AMENDMENTS AND RENEWALS IN ACCORDANCE WITH CITY BUDGETS: **PROVIDING** FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, the Purchasing Policies of the City of Deltona, Florida (the "City") authorize "piggybacking" on other competitively bid government contracts; and

WHEREAS, Volusia County has entered into Master Agreements MA 12439-1 and 12503-2 with Atlantic Pipe Services, LLC (the "Vendor") pursuant to competitive solicitations 22-B-112LS and 23-B-105LS, which are attached hereto and incorporated herein as Exhibit "A" (the "Volusia County Contracts"); and

WHEREAS, the City Commission desires to authorize the City Manager or his designee to issue purchase orders to the Vendor pursuant to a piggyback of the Volusia County Contracts in accordance with City Budgets; and

WHEREAS, the City Commission further desires to authorize the City Manager or his designee to award subsequent purchase orders and amendments on an annual basis to the Vendor that are in accordance with City Budgets.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

<u>Section 2.</u> Purchase Approved. That the City Manager or his designee is authorized to issue purchase orders in accordance with City Budgets to Atlantic Pipe Services, LLC under a piggyback of Volusia County Master Agreements MA 12439-1 and 12503-2 pursuant to competitive solicitations 22-B-112LS and 23-B-105LS.

<u>Section 3</u>. <u>Renewals and Purchase Orders Authorized</u>. That the City Manager or his designee is authorized to award purchase orders and amendments thereto on an annual basis in accordance with City Budgets.

Section 4. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

<u>Section 5</u>. <u>Effective Date</u>. That this Resolution shall become effective immediately upon its adoption.
