RESOLUTION NO. 2025-123

A RESOLUTION OF CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE THE AMENDED AND RESTATED AGREEMENT WITH WASTE PRO OF FLORIDA, INC. FOR SOLID WASTE COLLECTION, DISPOSAL, AND TRANSPORTATION SERVICES IN ACCORDANCE WITH RFP #18021 AND THE EXCLUSIVE COMMERCIAL SOLID WASTE FRANCHISE; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, the City of Deltona, Florida (the "City") sought proposals for residential solid waste collection, disposal, and transportation services through RFP #18021 (the "RFP"); and

WHEREAS, Waste Pro of Florida, Inc. (the "Contractor") was determined to be the most responsive and responsible proposer; and

WHEREAS, the City and Contractor entered into the Contract for Solid Waste Collection, Disposal and Transportation Services on July 23, 2018 in accordance with the RFP (the "2018 Contract"); and

WHEREAS, the City established an exclusive franchise with Waste Pro of Florida, Inc. for commercial solid waste services in accordance with Ordinance 06-2019; and

WHEREAS, the City and Contractor executed Amendment I to the Contract for Solid Waste Services on October 1, 2019 (the "First Amendment"); and

WHEREAS, the City and Contractor desire to extend the term of the initial contract for an additional seven (7) year term and have agreed to certain modifications as to price, service, and operations that are in the best interest of the City; and

WHEREAS, the City Commission desires to authorize the City Manager or his designee to execute the Amended and Restated Agreement for Solid Waste Collection, Disposal, and Transportation Services in substantially the form attached hereto as Exhibit "A" (the "Amended and Restated Agreement") and subject to any changes as required by the City Attorney.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. City Manager Authorized. That the City Manager or his designee is authorized to execute the Amended and Restated Agreement in substantially the form

attached hereto as Exhibit "A" (the "Second Amendment") and subject to any changes as required by the City Attorney.

Section 3. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
