A RESOLUTION OF CITY OF DELTONA, FLORIDA; **AUTHORIZING THE CITY MANAGER OR DESIGNEE TO** EXECUTE THE MASTER TELECOMMUNICATIONS LICENSE AGREEMENT WITH CROWN CASTLE FIBER. RECOGNIZING AN **EXEMPTION** COMPETITIVE BIDDING; AUTHORIZING RENEWALS; APPROVING THE ORDER FORM FOR REDUNDANT FIBER INTERNET SERVICE: AUTHORIZING EXECUTION OF FUTURE ORDER FORMS ISSUED PURSUANT TO THE **TELECOMMUNICATIONS** MASTER LICENSE AGREEMENT AND IN ACCORDANCE WITH CITY **BUDGETS; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.**

WHEREAS, the Purchasing Policy of the City of Deltona, Florida provides for an exemption from competitive bidding for communications services such as internet, telephone, and wireless services; and

WHEREAS, Crown Castle Fiber, LLC ("Crown Castle") is a provider of internet communication services; and

WHEREAS, the City of Deltona, Florida (the "City") has historically utilized services provided by Crown Castle to provide fiber internet connectivity, such as redundant internet connection for the Fire Department; and

WHEREAS, as the City continues to leverage cloud-based services in connection with efficient and cost-effective delivery of essential services, Crown Castle can provide a symmetric 1GB internet circuit to allow for balanced load distribution that can be used by all City departments; and

WHEREAS, Crown Castle provides internet communication services under a Master Telecommunications License Agreement, which is attached hereto and incorporated herein as Exhibit "A" (the "Master Agreement"); and

WHEREAS, Crown Castle has submitted an Order Form under the Master Agreement, which is attached hereto and incorporated herein as Exhibit "B" (the "Order Form"), to provide dedicated bandwidth at a guaranteed price of nine hundred and eighteen dollars (\$918.00) per month for thirty six (36) month, for a total amount not to exceed thirty three thousand forty eight dollars (\$33,048.00); and

WHEREAS, funds are budgeted and available for this purpose in the City Budget for Fiscal Year ending September 30, 2024; and

WHEREAS, the City Commission desires to authorize the City Manager or designee to execute the Master Agreement and approve the Order Form; and

WHEREAS, the City Commission further desires to authorize the City Manager or designee to execute any renewals to the Master Agreement and any additional Order Forms issued thereunder in accordance with City Budgets.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. City Manager Authorized. That the City Manager or designee is authorized to execute the Master Telecommunications License Agreement, which is attached hereto and incorporated herein as Exhibit "A" (the "Master Agreement"), subject to any changes as may be required by the City Attorney, and to approve the Order Form under the Master Agreement, which is attached hereto and incorporated herein as Exhibit "B" (the "Order Form"), to provide dedicated bandwidth at a guaranteed price of nine hundred and eighteen dollars (\$918.00) per month for thirty six (36) month, for a total amount not to exceed thirty three thousand forty eight dollars (\$33,048.00).

Section 3. Renewals Authorized. That the City Manager or designee is authorized to execute any renewals to the Master Agreement and any additional Order Forms issued thereunder in accordance with City Budgets.

Section 4. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 5. Effective Date. That this Resolution shall become effective immediately upon its adoption.
