RESOLUTION NO. 2025-40

A RESOLUTION OF CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER TO AWARD AN AGREEMENT WITH SEA LEVEL DEVELOPMENT LLC FOR DRAINAGE DITCH AND CANAL MOWING ONDEMAND SERVICES; PROVIDING FOR RENEWALS IN ACCORDANCE WITH CITY BUDGETS; PROVIDING IMPLEMENTATION AND AN EFFECTIVE DATE.

- WHEREAS, the City has miles of open ditches and canals that need routine maintenance and mowing and dredging to ensure positive stormwater conveyance; and
- WHEREAS, the City does not currently have sufficient operable equipment and manpower to accomplish all needed tasks efficiently; and
- **WHEREAS,** on July 1, 2024, the City released Invitation to Bid #24021 Drainage Ditch Mowing (the "Bid") to solicit vendors capable of providing on-demand maintenance services to the City; and
- WHEREAS, on July 18, 2024, the City closed the Bid after receiving two (2) responses; and
- WHEREAS, Sea Level Development LLC (the "Vendor") was determined to be the most responsive and responsible bidder; and
- WHEREAS, the City Commission desires to authorize the City Manager to award an agreement to the Vendor for drainage ditch and canal mowing on-demand services in an amount not to exceed eighty nine thousand six hundred dollars (\$89,600.00) annually; and
- WHEREAS, the City Commission desires to further authorize the City Manager to provide for subsequent renewals due to the potentially recurring nature of the services provided.
- NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:
- **Section 1.** Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.
- Section 2. City Manager Authorized. That the City Manager is authorized award an agreement with Sea Level Development LLC in accordance with the terms of

Bid #24021 – Drainage Ditch Mowing in an amount not to exceed eighty nine thousand six hundred dollars (\$89,600.00) annually.

Section 3. Renewals Authorized. That that City Manager is hereby authorized to execute subsequent annual renewals and extensions of the agreement, upon approval by the City Attorney as to legal sufficiency, and subject to budgeted funds.

Section 4. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 5. Effective Date. That this Resolution shall become effective immediately upon its adoption.
