## **RESOLUTION NO. 2025-110**

A RESOLUTION OF THE CITY OF DELTONA, FLORIDA; ACCEPTING A FEDERALLY FUNDED SUBAWARD FROM THE FLORIDA DIVISION OF EMERGENCY MANAGEMENT ("FDEM") FOR PROJECT 4680-052-R, PURCHASE AND INSTALLATION OF GENERATORS AT CITY HALL; AUTHORIZING THE CITY MANAGER AND/OR DESIGNEE TO EXECUTE THE SUBAWARD AGREEMENT; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

**WHEREAS,** the Federal Emergency Management Agency ("FEMA") awarded funding through the Hazard Mitigation Grant Program ("HMGP") to the Florida Division of Emergency Management ("FDEM"); and

**WHEREAS**, the FDEM has awarded the City of Deltona (the "City") a Federally Funded Subaward (the "Subaward") in the amount of seven hundred twenty thousand six hundred twenty five dollars (\$720,625.00) for Project 4680-052-R to purchase and install emergency generators at City Hall/Emergency Operations Center (the "Project"); and

**WHEREAS**, the City Commission desires to accept the Subaward and approve the Subaward Agreement, which sets forth the terms of the Subaward and is attached as Exhibit "A" (the "Subaward Agreement") and any related documents in a form approved by the City Attorney; and

WHEREAS, the estimated Project cost is six hundred ninety five thousand six hundred twenty five dollars (\$695,625.00) and the project management fees are twenty five thousand dollars (\$25,000.00) for a total cost of nine hundred twenty seven thousand five hundred dollars (\$927,500.00) and FDEM will reimburse seventy five percent (75%) of the cost or seven hundred twenty thousand six hundred twenty five dollars (\$720,625.00), the city is required to provide a cost-share of approximately two hundred six thousand eight hundred and seventy five dollars (\$206,875.00); and

**WHEREAS**, the City Commission finds that the adoption of this Resolution is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:
