## A. <u>Request for approval of Resolution No. 2025-61, Requesting board</u> <u>consideration and approval of a Matching Grant proposal which could</u> <u>potentially benefit businesses within the CRA boundary.</u>

The Economic Development Director gave a brief presentation on the Community Redevelopment Agency (CRA) types of grants, grant match and the grant proposal.

The Commission, the City Attorney and staff discussed who benefits from the matching grant, the CRA's portion of cost, City grants, potential candidates, annual amount earned by the CRA, the program running in perpetuity, the CRA expires in 10 years, increased cost shares, helping business partners in CRA, streetscaping program, improvements to City infrastructure, previous CRA decisions, paying as you go, changing policy for funding opportunities, having a workshop, debt and bonds, expansion of CRA, one grant per year per property, out parcels, sewer expansion, no restriction on City funds, exterior only

improvements, businesses to receive multiple grants per year, commercial only grants, staff approving the work before final payment, and approvals at staff level.

Motion by M. Avila-Vazquez, seconded by D. Heriot, to approve Resolution No. 2025-61 adopting the proposed Grant Program for the Southwest Deltona Community Redevelopment Agency located within the City of Deltona up to \$200,000 grant in addition to multiple grants per year and multiple categories per year is permitted.
