A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA, ADOPTING A PROPOSED OPERATING MILLAGE RATE OF AD VALOREM TAXATION FOR 2025-2026 FISCAL THE YEAR: DETERMINING THE ROLLED-BACK RATE: AUTHORIZING A PUBLIC HEARING AND DIRECTING PROVISION OF NOTICE THEREOF: PROVIDING FOR SCRIVENER'S ERRORS AND AN EFFECTIVE DATE.

WHEREAS, the City of Deltona has a proposed budget for its General Fund, which calls for revenues to be raised from ad valorem taxation; and

WHEREAS, pursuant to Section 200.065, Florida Statutes, the City of Deltona is required to advise the Property Appraiser of its proposed operating ad valorem taxation millage rate, its rolled back rate, and the date, time, and place that the public hearing will be held to consider the proposed millage rates and the tentative budget; and

WHEREAS, the recommended operating millage rate of ad valorem taxation for the fiscal year commencing on October 1, 2025, and ending on September 30, 2026 ("Fiscal Year 2025-2026") is 6.9500 mills, which is \$6.9500 per \$1,000.00 of assessed value; and

WHEREAS, the rollback rate is 6.5494 mills, which is \$6.5494 per \$1,000.00 of assessed value.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That the recitals set forth above are hereby adopted and confirmed.

Section 2. Proposed Operating Millage Tax Rate. The recommended operating millage rate of ad valorem taxation is 6.9500 mills, which is \$6.9500 per \$1,000.00 of taxable assessed value for Fiscal Year 2025-2026. The rolled-back rate is

6.5494 mills. The above-described proposed operating millage rate is 6.12% above the rolled-back rate as computed pursuant to State law.

Section 3. Tentative Public Hearing. Will be held on September 3, 2025, at 6:30 p.m., or as soon thereafter as may be heard, at Deltona City Hall, 2345 Providence Boulevard, Deltona, Florida, to consider the proposed millage rate and the tentative budget.

Section 4. Final Public Hearing. Will be held on September 15, 2025, at 6:30 p.m., or as soon thereafter as may be heard, at Deltona City Hall, 2345 Providence Boulevard, Deltona, Florida, to consider the final millage rate and the final budget.

Section 5. Scrivener's Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

Section 6. Effective Date. This Resolution shall become effective immediately upon its adoption.
