RESOLUTION NO. 2025-127

A RESOLUTION OF THE CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO AWARD AN AGREEMENT TO BRYDSON SERVICE, LLC PURSUANT TO ITB #25010 FOR ELEVATION OF FLOOD PRONE HOME LOCATED AT 2560 TULSA DRIVE WEST; PROVIDING FOR IMPLEMENTATION AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Deltona, Florida (the "City") applied for and received a Federally Funded Subaward from the State of Florida Division of Emergency Management ("FDEM") for the elevation of a flood prone home located at 2560 Tusla Drive West in Deltona, Florida (the "Subaward"); and

WHEREAS, pursuant to the Subaward, the City entered into Grant Agreement Number H1124 with Project Number 4680-024-R (the "Grant Agreement"); and

WHEREAS, in compliance with the terms of the Subaward and the Grant Agreement, the City issued ITB #25010 for elevation of a flood prone home located at 2560 Tulsa Drive West on April 28, 2025, which is attached hereto and incorporated herein along with any addenda and exhibits thereto as Exhibit "A" (the "ITB"); and

WHEREAS, Brydson Services, LLC (the "Vendor") submitted a response to the ITB, which is attached hereto and incorporated herein as Exhibit "B" (the "Vendor Proposal") and was determined to be the most responsive, responsible bidder; and

WHEREAS, the City Commission desires to authorize the City Manager or designee to award an agreement to the Vendor consistent with the terms of the Subaward, ITB, and Vendor Proposal, at a total cost not to exceed four hundred ten thousand five hundred seventy-one and 00/100 dollars (\$410,571.00), which is attached hereto and incorporated herein as Exhibit "C" (the "Agreement"), subject to any changes as may be required by the City Attorney or FDEM; and

WHEREAS, the City Commission further desires to authorize the City Manager or designee to execute change orders to the Agreement in an amount not to exceed ten percent (10%) of the total contract price.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. Authorization to Award. That the City Manager or designee is hereby authorized to award the ITB to the Vendor as the lowest, responsive and responsible bidder.

Section 3. Authorization to Enter into Agreement. That the City Manager or designee is hereby authorized to enter into an Agreement with the Vendor in accordance with the ITB at a total cost not to exceed four hundred ten thousand five hundred seventy-one and 00/100 dollars (\$410,571.00), which is attached hereto and incorporated herein as Exhibit "C" (the "Agreement"), subject to any changes as may be required by the City Attorney or FDEM and is further authorized to execute change orders to the Agreement in an amount not to exceed ten percent (10%) of the total contract price.

Section 4. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 5. Effective Date. That this Resolution shall become effective immediately upon its adoption.
