## **RESOLUTION NO. 2025-167**

A RESOLUTION OF CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER TO AWARD BID# 25021 – JANITORIAL SERVICES TO CLEAN SPACE, LLC AS THE MOST QUALIFIED RESPONSIVE AND RESPONSIBLE BIDDER; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

**WHEREAS,** on September 3, 2025, the City advertised Bid# 25021 – Janitorial Services, which is attached hereto as Exhibit "A" (the "Bid"); and

**WHEREAS**, on October 2, 2025, the City closed the Bid after receiving thirteen (13) responses; and

**WHEREAS,** after a complete review of the submittals, the selection committee by consensus chose Clean Space, LLC (the "Vendor") as the most qualified responsive and responsible bidder; and

WHEREAS, the City Commission desires to authorize the City Manager to award Bid# 25021 - Janitorial Services to the Vendor for an initial term of three (3) years with two (2) one (1) year renewal options in an amount not to exceed thirty-seven thousand one hundred and fifty-six dollars and twenty cents (\$37,156.20) annually.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

**Section 1. Recitals Adopted.** That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. City Manager Authorized.** That the City Manager is authorized to award Bid# 25021 - Janitorial Services to Clean Space, LLC for an initial term of three (3) years with two (2) one (1) year renewal options in an amount not to exceed thirty-seven thousand one hundred and fifty-six dollars and twenty cents (\$37,156.20) annually.

**Section 3. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 4. Effective Date.** That this Resolution shall become effective immediately upon its adoption.
