#### 6. DELTONA COMMUNITY EVENTS:

Mayor Avila gave a report on the budgetary process in the Senate with \$750,000 for the Theresa Basin-Mid Basin Pumping Project and the House budget with \$1,250,000 for the AWS Recharge Project and \$187,500 for the Theresa Basin Flooding Mitigation Project.

The City Manager reported on the \$1 million penalty being imposed on the City by the IRS (Internal Revenue Service) and the settlement will cost the City zero dollars. Second, the City received a \$139,000 grant from the Department of Energy to replace windows at City Hall. Third, the City received a \$1.5 million grant for the Fisher Plant upgrades from the Florida Department of Environmental Protection (FDEP) with the overall redesign of the Fisher Plant costing \$44 million and the City just received the Water Quality Improvement Grant in the amount of \$22 million from FDEP.

**City Commission** 

The Planning & Development Services Director gave a brief presentation to include three options.

The Commission and staff discussed the distance from schools, the number of dispensaries and location, existing nonconforming, and banning any more dispensaries.

Commissioner Santiago requested that the motion be amended to banning altogether any additional medical dispensaries in the City of Deltona. City Attorney Good replied if the it was the will of the Commission to do this the proper motion would be to table or deny the ordinance being presented because it will be a significant change.

Vice Mayor Heriot and Commissioner Colwell

The Commission, City Attorney and staff discussed tabling with direction, impact to drug stores, what other cities do, and increasing the 500 feet and state statute mandates.

City Attorney Good stated the motion on the floor is to deny Ordinance No. 07-2025 and he requested clarification if that motion also includes direction to staff to bring back a new ordinance that bans medical marijuana dispensaries and Vice Mayor Heriot replied it does, the intent was to include.

The Commission, the City Attorney and staff discussed what the ban would include, state licenses, not putting businesses out of business, clarifying the motion, Commissioner Lulli's personal experiences, other alternatives, benefits, City revenues, and not negatively impacting existing businesses.

#### 11. CITY MANAGER COMMENTS:

The City Manager stated the ordinance committee will appear on the next agenda and that each Commissioner will make an appointment keeping in mind that the appointees cannot already be serving on another City board/committee. Second, he recognized local groups who were involved with the Celtic Festival. Third, staff finished up internal meetings in preparation for community park meetings and he provided expected dates, times and locations.

#### 12. CITY COMMISSION COMMENTS, REQUESTS & REPORTS:

Commissioner Lulli spoke about comments made by the City Manager and providing information to the public, public forum, passive parks, Rhode Island Extension, and the Southwest Volusia Democratic Club and the Celtic Festival.

Commissioner Lulli requested a consensus that each Commissioner identifies one area within their district to use Tree Funds for a project with the focus on native trees that are specific to that habitat and echo system and the Commission concurred.

Commissioner Colwell requested a consensus to change the language in the City's Code of Ordinances, Chapter 2-Administration, Article IX-Sanctions For Charter Violation, Section 2-380. Violations where it states "All city commissioners, including the commissioner charged with a violation, may take part in and vote as to all matters relating in any way to the charge."

Mayor Avila asked for clarification, he thinks this is governed by state statute and City Attorney Good replied it is within the general Code of Ordinances and it would be an amendment to the ordinance with two readings.

He will do research to make sure there is no due process concerns if it is the will of the Commission to bring the change before them.

#### A majority of the Commission with the exception of Commissioner Santiago and Mayor Avila concurred with Commissioner Colwell's request.

Commissioner Avila-Vazquez spoke about AHAC (Affordable Housing Advisory Committee) membership, Celtic Festival, Deltona Blvd. welcome sign, the recent Saturday Special Commission Meeting and Workshop and the topics, lack of workshops, the **City Commission** 

makeup of the CRA (Community Redevelopment Agency), having workshops within 30 days with one or two subjects, policy, and having Saturday meetings only in an emergency.

Commissioner Howington spoke about echoing Commissioner Avila-Vazquez's comments, the topic of impact fees and bringing in a skilled, qualified company.

Commissioner Howington requested a consensus for staff to come back to the Commission with an RFP (Request For Proposal) or three or four price quotes to get the impact fee study started while there are zoning in progresses in place and work on impact fees that have not been adjusted in 10 years.

Mayor Avila asked for clarification and Finance Director replied tomorrow morning he is meeting with the firm that is handling water/sewer rates and impact fees. This Wednesday he is meeting with the Planning & Development Services Director to discuss all the other impact fees to include getting a proposal for Planning & Zoning fees, building fees, and all other fees that have not been looked at in the last couple of years. By the next Regular Commission Meeting he will have a response to the City Manager as to when he expects those studies to be complete. On May 5th there will be a budget amendment that will allow the City to pay for all the other impact fees other than water and sewer.

The Commission concurred with Commissioner Howington's request.

# Commissioner Howington requested a consensus to have staff look at the possibility of having non ad valorem exemptions with regards to certain assessments specifically for our service connected disability residents.

The Commission and City Attorney spoke about the amount per exemption, service fees, alternatives like an assistance program, and abstaining from a vote.

#### The Commission concurred with Commissioner Howington's request.

Commissioner Howington spoke about tractor trailer parking issues, Amazon, the Economic Development Manager is working on it, destruction to sidewalks and swells, researching potential options, a place being built, requiring businesses to provide space, ticketing vehicles, residential vs. commercial property, Deltona Retail Holdings, and providing a report. The City Manager stated staff will work on it.

Commissioner Howington spoke about bringing back the dispensaries as soon as possible, at next meeting. City Attorney Good replied the ordinance could be brought back at the second meeting in May.

Commissioner Santiago spoke about the Celtic Festival and Howland Blvd. pedestrian safety update.

Mayor Avila spoke about the City Manager report, upcoming job fair, Mother's Day event,

and suggested the Commissioners attend schools events.
