

## RESOLUTION NO. 2025-119

**A RESOLUTION OF THE CITY OF DELTONA, FLORIDA;  
AUTHORIZING THE CITY MANAGER OR DESIGNEE TO  
AMEND THE WORK AUTHORIZATION WITH LASSITER  
TRANSPORTATION GROUP, INC FOR THE RHODE  
ISLAND FEASABILITY STUDY ISSUED PURSUANT TO A  
CONTINUING SERVICES CONTRACT ISSUED UNDER  
RFQ #23021; PROVIDING FOR IMPLEMENTATION AND  
AN EFFECTIVE DATE.**

**WHEREAS**, the City of Deltona, Florida (the “City”) issued RFQ No. 23021 (the “RFQ”) seeking professional Transportation Engineering and/or Planning Services to create a pool of consultants available to the City; and

**WHEREAS**, Lassiter Transportation Group, Inc. (the “Consultant”) was awarded a continuing contract with the City pursuant to the RFQ (the “Continuing Contract”); and

**WHEREAS**, the City issued a Work Authorization, to the Consultant for the Rhode Island Avenue Feasibility Study in an amount not to exceed fifty nine thousand one hundred and sixty five dollars (\$59,165.00) (the “Work Authorization”); and

**WHEREAS**, the original scope included traffic engineering and transportation services, but it did not include a significant amount of stakeholder engagement; and

**WHEREAS**, the City Commission desires to authorize the City Manager or his designee amend the Work Authorization to a total amount not to exceed eighty nine thousand one hundred and fifteen dollars (\$89,115.00) to include additional stakeholder engagement services.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Purchase Approved.** That the City Manager or designee is authorized to amend the Work Authorization with Lassiter Transportation Group, Inc. for the Rhode Island Avenue Feasibility Study issued pursuant to a continuing contract under RFQ #23021 to a total amount not to exceed eighty nine thousand one hundred and fifteen dollars (\$89,115.00) to include additional stakeholder engagement services.

**Section 3. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 4. Effective Date.** That this Resolution shall become effective immediately upon its adoption.
