RESOLUTION NO. 2025-59

A RESOLUTION OF CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER TO AWARD AN AGREEMENT TO MEAD AND HUNT, INC. FOR DESIGN, ENGINEERING, AND PERMITTING SERVICES RELATED TO THE DELTONA LAKES WATER RECLAMATION FACILITY; PROVIDING IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, on January 26, 2024, the City was awarded a grant from the Florida Department of Environmental Protection LPA 0510 for design, engineering, and permitting to bring Deltona Lakes Water Reclamation Facility up to current Florida Department of Environmental regulation standards of Advanced Waste Treatment (the "Grant"); and

WHEREAS, the Grant provides funding in an amount of one million five hundred thousand dollars (\$1,500,000.00) that requires a fifty percent (50%) match grant to come from Enterprise Funds; and

WHEREAS, on September 11, 2024, the City advertised RFQ#24034 – Water Reclamation Facility Final Design and Permitting Services to solicit vendors capable of providing services to the City, which is attached hereto as Exhibit "A" (the "RFQ"); and

WHEREAS, on October 17, 2024, the City closed the RFQ after receiving one (1) response; and

WHEREAS, Mead and Hunt, Inc. (the "Vendor") was the only one qualified responsive and responsible bidder; and

WHEREAS, the City Commission desires to authorize the City Manager to award an agreement to the Vendor for Water Reclamation Facility Final Design and Permitting Services in an amount not to exceed four million twenty-two thousand three hundred sixtyeight dollars (\$4,022,368.00).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. City Manager Authorized. That the City Manager is authorized award an agreement with Mead and Hunt, Inc. in accordance with the terms of RFQ#24034 – Water Reclamation Facility Final Design and Permitting Services in an amount not to exceed four million twenty-two thousand three hundred sixty-eight dollars (\$4,022,368.00).

Section 3. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
