

RESOLUTION NO. 2026-70

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;
AUTHORIZING THE CITY MANAGER TO AWARD
PURCHASE ORDER IN ACCORDANCE WITH CITY
BUDGETS TO FIELDCRAFT BUILDERS, LLC., FOR
SYNTHETIC TURF INSTALLATION AT KEYSVILLE DOG
PARK, PURSUANT TO A COMPETITIVELY SOLICITED
SOURCEWELL CONTRACT NUMBER: 031622-H21;
PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE
DATE.**

WHEREAS, the City Commission previously approved the parks improvement Project under Resolution No. 2026-30, which includes, among other items, the installation of artificial turf at both the small and large dog entrances at Keysville Dog Park; and

WHEREAS, Fieldcraft Builders has been identified as a contractor able to provide artificial turf installation services through competitively solicited Sourcewell Contract No. **031622-H21**, which Contract has been extended until May 26, 2027 at the 2026 rates, and otherwise satisfying all applicable procurement requirements and ensuring competitive pricing; and

WHEREAS, it is in the best interest of the Commission and the community to proceed with the artificial turf installation as part of the previously approved Parks Improvement Project;

WHEREAS, in accordance with the City's Purchasing Policy, through Commodities or Contractual Services that are competitively bid and awarded by other governmental agencies (including GSA) or cooperatives using the same terms and conditions, and prices (or below such prices) and is considered economically advantageous to the City; and

WHEREAS, Fieldcraft Builders LLC. submitted a proposal to provide artificial turf at both the small and large dog entrances at Keysville Dog Park at a price not to exceed one hundred thirty-three thousand one hundred ninety-four dollars (\$133,194.00), which is attached hereto and incorporated herein as Exhibit "A" (the Proposal); and

WHEREAS, the City Commission desires to authorize the City Manager or his designee to award purchase order to Fieldcraft Builders LLC for the completion of the installation of the artificial turf at Keysville Dog Park in accordance with the Proposal; and

WHEREAS, the City Commission desires to authorize the City Manager to execute change orders to the Proposal in an amount not to exceed ten percent (10%) of the total cost for the Proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. Purchase Approved. That the City Manager or designee is authorized to award purchase order to Fieldcraft Builders LLC. at a price not to exceed one hundred thirty-three thousand one hundred ninety-four dollars (\$133,194.00) in accordance with the Proposal attached hereto and incorporated herein as Exhibit "A" and is further authorized to execute change orders in an amount not to exceed ten percent (10%) of the total cost of the Proposal.

Section 3. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
