

RESOLUTION NO. 2025-39

A RESOLUTION OF CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER TO AWARD PURCHASE ORDERS IN ACCORDANCE WITH CITY BUDGETS TO FAUSNIGHT STRIPING & LINE, PURSUANT TO THE CITY OF DELTONA PIGGYBACK AGREEMENT WITH FAUSNIGHT STRIPING & LINE, ENTERED INTO PURSUANT TO SEMINOLE COUNTY CONTRACT #IFB-604562-23/LNF, AS AMENDED; PROVIDING FOR RENEWALS IN ACCORDANCE WITH CITY BUDGETS; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, the City of Deltona (the “City”) has nearly 500 miles of roadways, many of which were constructed in the 1960s; and

WHEREAS, in 2018 the City undertook a Pavement Condition Index (“PCI”) inventory of all the roadways under the City of Deltona’s jurisdictional control; and

WHEREAS, this PCI provides a ranking of roadway conditions from zero to one hundred, with zero being the poorest condition; and

WHEREAS, the City utilizes the PCI to strategically focus roadway improvements; and

WHEREAS, upon completion of milling & resurfacing of a roadway pavement marking/stripping must also be replaced and upgraded; and

WHEREAS, the Purchasing Policies of the City of Deltona authorize “piggybacking” on other competitively bid government contracts; and

WHEREAS, Seminole County has entered into Agreement with Fausnight Stripe & Line, Inc. (“Fausnight”) pursuant to competitive solicitation IFB-604562-23/LNF (the “Seminole County Contract”); and

WHEREAS, the City previously executed a piggyback agreement with Fausnight on February 7, 2024, which is attached hereto as Exhibit “A” (the “Piggyback Agreement”); and

WHEREAS, the City subsequently entered into the first amendment to the piggyback agreement with Fausnight on March 18, 2025, which is attached hereto as Exhibit “B” (the “First Amendment”); and

WHEREAS, the City now desires to award purchase orders to Fausnight in accordance with the terms of the Piggyback Agreement and First Amendment at a price not to exceed ninety-five thousand seven hundred forty-eight dollars and ninety-five cents (\$95,748.95), which is attached hereto as Exhibit "C" (the "Proposal"); and

WHEREAS, the City further desires to authorize the City Manager or his designee to award subsequent purchase orders to Fausnight pursuant to the Piggyback Agreement and First Amendment that are in accordance with City Budgets and to renew and amend the Piggyback Agreement, as amended by the First Amendment, and issue purchase orders on an annual basis in accordance with City Budgets.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. Purchase Approved. That the City Manager or his designee is authorized to accept the Proposal purchase in substantially the form which is attached hereto.

Section 3. Renewals and Purchase Orders Authorized. That the City Manager or his designee is authorized to renew and amend the Piggyback Agreement, as amended by the First Amendment, and award purchase orders on an annual basis in accordance with City Budgets.

Section 4. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 5. Effective Date. That this Resolution shall become effective immediately upon its adoption.

EXHIBIT A

CITY OF DELTONA, FLORIDA
PIGGYBACK AGREEMENT

The City of Deltona ("City") enters this "Piggyback" Agreement with FAUSNIGHT STRIPE AND LINE, INC., (hereinafter referred to as the "Contractor"), under the terms and conditions hereinafter provided. The City and the Contractor agree as follows:

1. The Purchasing Policies of the City Deltona allow for "piggybacking" contracts.

Pursuant to this procedure, the City is allowed to piggyback on an existing government contract, and there is no need to obtain formal or informal quotations, proposals or bids. The parties agree that the Contractor has entered into an agreement with SEMINOLE COUNTY, said agreement being identified as: Exhibit A - SEMINOLE COUNTY AGREEMENT AND IFB-604562-23/LNF, ROADWAY MARKINGS, STRIPING AND BRICK TEXTURE SURFACING in accordance and compliance with all specifications, terms and conditions set forth in IFB-604562-23/LNF.

2. The original government agreement is incorporated herein by reference and is attached as Exhibit "A" to this Agreement. All the terms and conditions set out in the original government Agreement (Exhibit "A") are fully binding on the parties and said terms and conditions are incorporated herein.

a. Compensation: FAUSNIGHT STRIPE AND LINE, INC. has proposed to provide services per the attached document labeled as Exhibit "B". Fees for any additional work needed will be agreed upon in writing prior to any service being completed.

b. Invoices shall be submitted in duplicate to the City of Deltona, Accounts Payable, and 2345 Providence Blvd., Deltona, FL 32725. Each invoice shall contain the purchase order number and a detailed description of services and fees.

c. The City shall make payment on all invoices in accordance with the Florida Prompt Payment Act, sections 218.70 through 218.79, Florida Statutes.

d. The City shall make progress payments due to the Contract Price on the basis of Contractor's monthly Applications for Payment, as approved by the City. Applications for payment shall be submitted by the Contractor between the first (1st) and the tenth (10th) day after the end of each calendar month for which payment is requested. All progress payments will be made based on the progress of the work completed and accepted by the City.

e. The Contractor shall not be entitled to payment for any other expenses, fees, or other costs it may incur at any time beyond the contract price. The Contractor hereby agrees that the total contract cost is inclusive of all overhead and administrative expenses.

3. Public Records: The Contractor shall allow public access to all documents, papers, letters, or other material subject to the provisions of Chapter 119, Florida Statutes, and made or received by the Contractor in conjunction with this Agreement. Specifically, the Contractor shall:

- a. Keep and maintain public records that ordinarily and necessarily would be required by the City in order to perform the service.
- b. Upon request of the City's custodian of public records, provide the City with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in state law or as otherwise provided by law.
- c. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the Agreement term and following completion of the Agreement if the Contractor does not transfer the records to the City.
- d. Meet all requirements for retaining public records and transfer, at no cost, to the City all public records in possession of the Contractor upon termination of the Agreement and destroy and duplicate public records that are exempt or confidential and exempt from the public records disclosure requirements. All records stored electronically must be provided to the City in a format that is compatible with the information technology system of the City.
- e. **IF THE CONTRACTOR HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO THE FIRM'S DUTY TO PROVIDE PUBLIC RECORDS RELATING TO THIS CONTRACT, CONTACT THE CUSTODIAN OF PUBLIC RECORDS AT (386) 878-8100, jraftery@deltonafl.gov, 2345 Providence Blvd., Deltona, Florida 32725.**

4. Additional terms:

- a. The services, as described herein, to be rendered by the Contractor, are to be completed on or before August 28, 2026. Term may be extended based on accepted renewals with Seminole County. If the current pandemic or an emergency situation slows production, material procurement or labor force, the City and Contractor will work to extend the agreement by an agreed upon time frame and the Contractor would not be penalized for project delays.**
- b. Pursuant to the terms and conditions set forth in this Agreement, City hereby engages Contractor to perform services related to ROADWAY MARKINGS, STRIPING AND BRICK TEXTURE SURFACING.**
- c. The services to be rendered by the Contractor shall include all labor, materials, equipment and incidentals necessary to perform all work indicated and specified in Exhibit A.**
- d. Contractor has familiarized itself with the nature and extent of the contract documents, work, site, locality, and all local conditions and laws and regulations that in any manner may affect cost, progress, performance or furnishing of the work.**
- e. Contractor has obtained and carefully studied (or assumes responsibility for obtaining and carefully studying) all examinations, investigations, explorations, tests, reports and studies which pertain to the physical conditions at or contiguous to the site or otherwise may affect the cost, progress, performance or furnishing of the work as Contractor considers necessary for the performance or furnishing of the work at the contract price, within the contract time and in accordance with the other terms and conditions of the contract documents and no additional examinations, investigations, explorations, tests, reports, studies or similar information or data are or will be required by Contractor for such purposes.**
- f. Contractor acknowledges that nothing herein shall be deemed to preclude the City from retaining the services of other persons or entities undertaking the same or similar services as those undertaken by the Contractor or from independently developing or acquiring materials or programs that are similar to or competitive with, the services provided under this Agreement.**
- g. Contractor shall be responsible for obtaining all required federal, state or local permits required to complete the scope of work under this agreement.**
- h. Contractor shall be responsible for the quality of work performed. Contractor shall, without additional compensation, correct or revise any errors or deficiencies in his services.**
- i. Contractor agrees to provide a one-year maintenance period to correct any defective work that may be found within the one year period from the time of completion.**

5. **Venue:** The venue of any dispute will be in Volusia County, Florida. Litigation between the parties arising out of this Agreement must be in Volusia County, Florida in the Court of appropriate jurisdiction. The laws of Florida will control any dispute between the parties arising out of or related to this Piggyback Agreement, the performance thereof or any products or services delivered pursuant to such Agreement.

6. **Insurance:** Contractor shall provide and maintain, during the entire term of this Agreement, without cost to the City, insurance in the following types and limits with a company or companies authorized to do business in the State of Florida and rated "Class A" or better by A. M. Best or some other form of assurance approved by the City's Risk Manager. Contractor shall not commence work under the Agreement until City has received an acceptable certificate or certificates of insurance and endorsement evidencing the required insurance, which is as follows:

a. General Liability insurance on forms no more restrictive than the latest edition of the Commercial General Liability policy (CG 00 01 or CG 00 02) of the Insurance Services Office or equivalent without restrictive endorsements, with the following minimum limits and coverage available limits fully available during the entire contract period:

b. Automobile liability insurance, including owned, non-owned and hired autos with the following minimum limits and coverage:

Bodily Injury (per accident)	\$1,000,000
Property Damage	\$ 100,000

c. Workers' compensation insurance in accordance with Florida Statute, Chapter 440, and/or any other applicable law requiring workers' compensation (Federal, maritime, etc).

d. Contractors pollution liability policy with minimum limits and coverage of \$1,000,000 each loss/aggregate.

- e. City of Deltona shall be **named and endorsed** as an additional insured on the General liability policy.
- f. The General Liability policy is to contain or be endorsed to name the City, its officers, officials and employees as additional insureds as respects to the liability arising out of the activities performed under this Agreement. Such coverage shall be primary to the extent of Contractors negligent acts or omissions or willful misconduct and shall apply separately to each insured against whom claim is made or suit is brought, except with respect to the limits of the insurer's liability; the City shall be non-contributory. In addition, a waiver of subrogation by the commercial liability insurer shall be provided that lists or names the additional insured as subject to the waiver. Coverage shall be on an "occurrence" basis and not "claims made".
- g. Certificates of insurance shall provide for a minimum of thirty (30) days prior written notice to the City of any material change or cancellation of the required insurance, with ten (10) day written notice of cancellation due to non-payment of premium.
- h. Certificates of insurance shall identify the Bid number, contract, project, etc. in the Description of Operations section of the Certificate.
- i. Contractor shall be responsible for subcontractors and their insurance.
- j. The Certificate holder section of each policy shall state: City OF DELTONA, 2345 PROVIDENCE BOULEVARD, DELTONA, FLORIDA 32725.
- k. Contractor shall be solely responsible for all deductibles and self-insurance retention on Contractor Liability Insurance policies. All of the policies of insurance so required to be purchased and maintained shall contain a provision or endorsement that the coverage afforded shall not be canceled, materially changed or renewal refused without thirty (30) calendar days written notice, or without ten (10) days written notice of cancellation due to non-payment of premium, being given to City by certified mail.
- l. **Indemnity**. Contractor shall indemnify, defend and hold harmless City, its officers and employees, from liabilities, damages, losses and costs, including, but not limited to, reasonable attorney's fees, to the extent caused by the negligence, recklessness or intentional wrongful misconduct of Contractor and persons employed or utilized by Contractor in the performance of this Contract. This indemnification shall survive the term of this Contract. In addition, any act alleged to give rise to an action in inverse condemnation shall be subject to the same indemnification.

m. Independent Contractor. Contractor agrees that it shall be acting as an independent contractor and shall not be considered or deemed to be an agent, employee, in a joint venture, or partner of City. Contractor shall have no authority to contract for or bind City in any manner and shall not represent itself as an agent of City or as otherwise authorized to act for or on behalf of City.

n. **NO CLAIM FOR DAMAGES OR ANY CLAIM OTHER THAN FOR AN EXTENSION OF TIME SHALL BE MADE OR ASSERTED AGAINST THE CITY BY REASON OF ANY DELAYS.** No interruption, interference, inefficiency, suspension or delay in the commencement or progress of the work from any cause whatsoever, shall relieve the Contractor of his duty to perform or give rise to any right to damages or additional compensation from the City. The Contractor expressly acknowledges and agrees that the Contractor shall receive no damages for delay. The Contractor's sole remedy, if any, against the City shall be the right to seek an extension to the contract time.

o. Retaining Other Contractors by City. Nothing herein shall be deemed to preclude the City from retaining the services of other persons or entities undertaking the same or similar services as those undertaken by the Contractor or from independently developing or acquiring materials or programs that are similar to or competitive with, the services provided under this Agreement.

p. Accuracy. The Contractor is responsible for the professional quality, technical accuracy, timely completion and coordination of all the services furnished hereunder. The Contractor shall, without additional compensation, correct or revise any errors, omissions or other deficiencies in its services.

q. Codes and Regulations. All work completed under this Agreement shall at all times comply with all applicable federal, state and local statutes, codes, regulations and ordinances.

r. Public Entity Crimes. A person or affiliate who has been placed on the convicted vendor list following a conviction of a public entity crime may not be awarded or perform work as a contractor, supplier, subcontractor, or engineer under a contract with any public entity in excess of the threshold amount provided in Florida Statutes, section 287.017 for Category Two for a period of thirty-six (36) months from the date of being placed on the convicted vendor list.

s. Prohibition against Contingent Fees. Contractor warrants that they have not employed or retained any company or person, other than a bona fide employee working solely for the Contractor to solicit or secure this Agreement and that they have not paid or agreed to pay any person, company, corporation, individual, or firm, other than a bona fide employee working solely for the Contractor, any fee, commission, percentage, gift or

other consideration contingent upon or resulting from the award or making of this Agreement.

EXHIBIT B

**AMENDMENT TO PIGGYBACK AGREEMENT BETWEEN
THE CITY OF DELTONA AND FAUSNIGHT STRIPE AND LINE, INC.**

This Amendment to the Piggyback Agreement Between City of Deltona and Fausnight Stripe and Line, Inc. ("Amendment") is made as of 03/19/2025, (the "Effective Date") between the City of Deltona, Florida, a Florida municipal corporation, with its principal place of business located at 2345 Providence Boulevard, Deltona, Florida 32725 (the "City") and Fausnight Stripe and Line, Inc., a Florida profit corporation, with its principal place of business located at 910 Charles Street, Longwood, Florida 32750 (the "Contractor") with each being referred to herein as a Party or collectively as the "Parties."

WHEREAS, the City and Contractor entered into the Piggyback Agreement Between City of Deltona and Fausnight Stripe and Line, Inc. on February 7, 2024 (the "Agreement"); and

WHEREAS, the City and Contractor desire to modify the agreement to accept new pricing pursuant to Seminole County Contract #IFB-604562-23/LNF; and

WHEREAS, the State of Florida requires that contracts between local governments and business entities include certain statutorily required clauses and affidavits.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agreement is hereby amended to incorporate the following:

1. **Amendment of Article 2.** Article 2. shall be amended as follows:

The original government agreement and the First Amendment to Term Contract for Roadway Markings, Striping, and Brick Texture Surfacing is incorporated herein by reference and is attached as composite Exhibit "A" to this Agreement. All the terms and conditions set out in the original government Agreement and its First Amendment (Exhibit "A") are fully binding on the parties and said terms and conditions are incorporated herein.

2. **Deletion and Replacement of Exhibit "A."** Exhibit "A" to the Agreement shall be deleted and replaced with composite Exhibit "A," attached hereto, which includes both the original Seminole County Agreement and the First Amendment.

3. **Addition of Article 7. State Required Affidavits.** Article 7. shall be added as follows:

7. By entering into this Agreement, the Contractor agrees to review and comply with the following state affidavit requirements:

- a. **Public Entity Crimes Affidavit.** Contractor shall comply with Section 287.133, Florida Statutes (Public Entity Crimes Statute), notification of which is hereby incorporated herein by reference, including execution of any required affidavit.

- b. **Scrutinized Companies.** Contractor certifies that it is not on the Scrutinized Companies that Boycott Israel List or engaged in a boycott of Israel. Pursuant to section 287.135, Florida Statutes, the CITY may immediately terminate this Agreement at its sole option if the Contractor is found to have submitted a false certification; or if the Contractor is placed on the Scrutinized Companies that Boycott Israel List or is engaged in the boycott of Israel during the term of the Agreement. If this Agreement is for more than one million dollars, the Contractor certifies that it is also not on the Scrutinized Companies with Activities in Sudan, Scrutinized Companies with Activities in the Iran Terrorism Sectors List, Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, or engaged with business operations in Cuba or Syria as identified in Section 287.135, Florida Statutes. Pursuant to Section 287.135, Florida Statutes, the CITY may immediately terminate this Agreement at its sole option if the Contractor is found to have submitted a false certification; or if the Contractor is placed on the Scrutinized Companies with Activities in Sudan List, Scrutinized Companies with Activities in the Iran Terrorism Sectors List, Scrutinized Companies with Activities in Iran Petroleum Energy Sector List, or engaged with business operations in Cuba or Syria during the term of the Agreement.
- c. **E-Verify Affidavit.** In accordance with Section 448.095, Florida Statutes, the CITY requires all contractors doing business with the CITY to register with and use the E-Verify system to verify the work authorization status of all newly hired employees. The CITY will not enter into a contract unless each party to the contract registers with and uses the E-Verify system. The contracting entity must provide of its proof of enrollment in E-Verify. For instructions on how to provide proof of the contracting entity's participation/enrollment in E-Verify, please visit: <https://www.e-verify.gov/faq/how-do-i-provide-proof-of-my-participationenrollment-in-e-verify>. By entering into this Agreement, the Contractor acknowledges that it has read Section 448.095, Florida Statutes; will comply with the E-Verify requirements imposed by Section 448.095, Florida Statutes, including but not limited to obtaining E-Verify affidavits from subcontractors; and has executed the required affidavit attached hereto and incorporated herein.
- d. **Noncoercive Conduct Affidavit.** Pursuant to Section 787.06, Florida Statutes, a nongovernmental entity executing, renewing, or extending a contract with a governmental entity is required to provide an affidavit, signed by an officer or a representative of the nongovernmental entity under penalty of perjury, attesting that the nongovernmental entity does not use coercion for labor or services as defined in Section 787.06(2)(a), Florida Statutes. By entering into this Agreement, the Contractor acknowledges that it has read Section 787.06, Florida Statutes, and will comply with the requirements therein, and has executed the required affidavit attached hereto and incorporated herein.
- e. **Prohibition on Contracting with Entities of Foreign Concern.** Pursuant to Section 287.138, Florida Statutes (which is expressly incorporated herein by

reference), a governmental entity may not knowingly enter into a contract with an entity which would give access to an individual's personal identifying information if (a) the entity is owned by the government of a foreign country of concern; (b) the government of a foreign country of concern has a controlling interest in the entity; or (c) the entity is organized under the laws of or has its principal place of business in a foreign country of concern. By entering into this Agreement, the Contractor acknowledges that it has read Section 287.138, Florida Statutes, and complies with the requirements therein, and has executed the required affidavit attached hereto and incorporated herein.

4. **Ratification of Agreement.** The Agreement, as modified by this Second Amendment, remains in full force and effect. In the event of any conflict between the Agreement and this Second Amendment, the terms and conditions of this Second Amendment will apply.

IN WITNESS WHEREOF, Contractor has signed and delivered this Agreement, and the City has caused this Agreement to be signed and delivered by its duly authorized officer or representative, all as of the date first set forth above.



AFFIDAVIT REGARDING PROHIBITION ON CONTRACTING WITH ENTITIES OF FOREIGN COUNTRIES OF CONCERN

Pursuant to Section 287.138, Florida Statutes (which is expressly incorporated herein by reference), a governmental entity may not knowingly enter into a contract with an entity which would give access to an individual's personal identifying information if (a) the entity is owned by the government of a foreign country of concern; (b) the government of a foreign country of concern has a controlling interest in the entity; or (c) the entity is organized under the laws of or has its principal place of business in a foreign country of concern.






