

RESOLUTION NO. 2025-112

A RESOLUTION OF CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO AMEND THE PURCHASE ORDER FOR ODYSSEY MANUFACTURING COMPANY, INC. ISSUED AS A PIGGYBACK OF THE MARION COUNTY CONTRACT #19B-265 WITH ODYSSEY MANUFACTURING COMPANY, INC.; PROVIDING FOR AMENDMENTS AND RENEWALS IN ACCORDANCE WITH CITY BUDGETS; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, the Purchasing Policies of the City of Deltona, Florida (the “City”) authorize “piggybacking” on other competitively bid government contracts; and

WHEREAS, Marion County has entered into Contract #19B-265 with Odyssey Manufacturing Company (the “Vendor”) pursuant to a competitive solicitation (the “Piggyback”) and

WHEREAS, the City issued a Purchase Order to the Vendor pursuant to the Piggyback in an amount not to exceed two hundred and nine thousand dollars (\$209,000.00) for the provision of Sodium Hypochlorite Solution and other related treatment chemicals at the Fisher Wastewater Treatment Plant (the “Chemicals”); and

WHEREAS, due to delays in availability of equipment and supplies, the rehabilitation of the filters at the Fisher Wastewater Plant is delayed, which has resulted in higher than expected consumption of the Chemicals, which are a critical part of the wastewater treatment process to meet Florida Department of Environmental Protection standards for disinfection; and

WHEREAS, an additional eighty thousand dollars (\$80,000.00) is needed for the Chemicals through the end of Fiscal Year 2024-2025; and

WHEREAS, the City Commission desires to authorize the City Manager or his designee to amend the Purchase Order with the Vendor to an amount not to exceed two hundred eighty-nine thousand dollars (\$289,000.00); and

WHEREAS, the City Commission further desires to authorize the City Manager or his designee to award subsequent purchase orders and amendments to the Vendor on an annual basis that are in accordance with City Budgets.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. Purchase Approved. That the City Manager or his designee is authorized to amend the Purchase Order 250320 with Odyssey Manufacturing Company, Inc., issued as a piggyback of the Marion County Contract # 19B-265, from two hundred and nine thousand dollars (\$209,000.00) to two hundred eighty-nine thousand dollars (\$289,000.00).

Section 3. Renewals and Purchase Orders Authorized. That the City Manager or his designee is authorized to award purchase orders and amendments thereto on an annual basis in accordance with City Budgets.

Section 4. Implementation. That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

Section 5. Effective Date. That this Resolution shall become effective immediately upon its adoption.
