

**RESOLUTION NO. 2025-34**

**A RESOLUTION OF CITY OF DELTONA, FLORIDA;  
DECLARING CERTAIN PERSONAL PROPERTY OWNED  
BY THE CITY OF DELTONA AS SURPLUS PROPERTY  
AND AUTHORIZING THE CITY MANAGER TO PROVIDE  
FOR THE SALE OR DISPOSAL OF SUCH PROPERTY IN  
ACCORDANCE WITH CITY PROCUREMENT POLICY;  
PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, over time, certain tangible personal property of the City of Deltona (the “City”) becomes obsolete or loses its usefulness due to replacement, upgrade, or loss of functionality; and

**WHEREAS**, City Procurement Policy 12.02 authorizes such property to be designated as surplus disposed of by the most appropriate means available; and

**WHEREAS**, the City Commission hereby finds and determines that the items listed or described in Exhibit “A,” as attached hereto, constitute surplus property pursuant to City Procurement Policy 12.02.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE  
CITY OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** Each of the above stated recitals is hereby adopted and confirmed.

**Section 2. Determination.** The City of Deltona hereby finds and determines the tangible personal property listed or described in Exhibit “A” constitutes surplus property eligible for disposal according to City Procurement Policy 12.02.

**Section 3. Disposition Authorized.** The City Manager or his designee is hereby authorized to dispose of the above referenced surplus items via public auction or by other procedures established by the City Manager. Surplus property items may be donated by the City to non-profit entities or other governmental entities upon determination by the City Manager and in accordance with the law.

**Section 3. Effective Date.** This resolution shall take effect immediately upon its final adoption by the City Commission.
