

**RESOLUTION NO. 2026-39**

**A RESOLUTION OF THE CITY OF DELTONA, FLORIDA; ACCEPTING A FEDERALLY FUNDED SUBAWARD IN THE AMOUNT OF \$323,752.25 FROM THE FLORIDA DIVISION OF EMERGENCY MANAGEMENT (“FDEM”) UNDER THE HAZARD MITIGATION GRANT PROGRAM (“HMGP”) FOR PROJECT 4734-018-R; APPROVING THE SUBAWARD AGREEMENT; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Federal Emergency Management Agency (“FEMA”) Hazard Mitigation Grant Program (“HMGP”) provides funding to state, local, tribal and territorial governments so they can develop hazard mitigation plans and rebuild in a way that reduces, or mitigates, future disaster losses in their communities; and

**WHEREAS**, the Florida Division of Emergency Management (“FDEM”) has awarded the City of Deltona, Florida (the “City”) a Federally Funded Subaward (the “Subaward”) in the amount of \$323,752.25 under FEMA’S HMPG for Project 4734-018-R; and

**WHEREAS**, the Subaward is to be used to mitigate flood risk through acquisition and demolition of the single-family property located at 3101 Riverhead Drive, Deltona, Florida 32738 (the “Property”); and

**WHEREAS**, the Subaward requires a funding match of \$101,285.75 to be provided by the City; and

**WHEREAS**, the City Commission desires to accept the Subaward and approve the Subaward Agreement H1144, which sets forth the terms of the Subaward and is attached as Exhibit “A” (the “Subaward Agreement”) and any related documents in a form approved by the City Attorney; and

**WHEREAS**, the City Commission finds that the adoption of this Resolution is in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Subaward Accepted.** That the City hereby accepts the Subaward.

**Section 3. Agreement Approved.** That the City Commission hereby approves the Subaward Agreement with FDEM, in substantially the form attached hereto as Exhibit "A."

**Section 4. Implementation.** That the City Manager or his designee is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 5. Effective Date.** That this Resolution shall become effective immediately upon its adoption.
