## **RESOLUTION NO. 2025-45**

A RESOLUTION OF CITY OF DELTONA, FLORIDA; AWARDING A PURCHASE ORDER FOR FIRE TRAINING PROPS FROM FIREBLAST GLOBAL PURSUANT TO GSA SOLICITATION NUMBER 47QSWA20D007M; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, the City of Deltona (the "City") approved the Fiscal Year 2025 Budget for the Fire Department with \$200,000 for training complex enhancements of which \$188,3000 is available; and

WHEREAS, the Fire Department requires the purchase of propane-based fire props to enhance firefighter training by improving fire assault techniques and overall training efficiency; and

WHEREAS, Fireblast Global submitted a proposal to provide the fire props during Fiscal Year 2025 at a price not to exceed fifty-eight thousand nine hundred ninety-five dollars and fifty-four cents (\$58,995.54), which is attached hereto as "Exhibit A" (the "Proposal"); and

WHEREAS, the Purchasing Policies of the City of Deltona authorizes the use of cooperative purchasing programs; and

WHEREAS, Fireblast Global is a respondent to GSA cooperative solicitation 47QSW20D007M; and

WHEREAS, the City Commission desires to authorize the City Manager or his designee to utilize this cooperative purchasing program to award a purchase order to Fireblast Global pursuant to the Proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

<u>Section 1</u>. <u>Recitals Adopted</u>. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

<u>Section 2</u>. <u>Purchase Approved</u>. That the Proposal, in substantially the form which is attached hereto, is approved, and the City Manager or his designee is authorized to accept the Proposal, once approved by the City Attorney as to form and legal sufficiency.

**Section 3. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> That this Resolution shall become effective immediately upon its adoption.
