

## RESOLUTION NO. 2025-97

**A RESOLUTION OF CITY OF DELTONA, FLORIDA; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO APPROVE A WORK AUTHORIZATION WITH PEGASUS ENGINEERING, LLC TO REVIEW AND UPDATING ARTICLE IV, "STORMWATER" OF CHAPTER 98, "NATURAL RESOURCES PROTECTION," OF THE LAND DEVELOPMENT CODE, PURSUANT TO RFQ PW-2020-08 - CONTINUING ON-CALL STORMWATER ENGINEERING SERVICES; PROVIDING IMPLEMENTATION AND AN EFFECTIVE DATE.**

**WHEREAS**, the City of Deltona is currently engaged in "Zoning in Progress" regarding updates to Article IV, "Stormwater," of Chapter 98, "Natural Resources Protection," of the Land Development Code (the "Stormwater Code"); and

**WHEREAS**, the City desires to update the Stormwater Code to be responsive to the impacts of hurricanes and extreme rainfall events that causes serious flooding and drainage impacts on the community; and

**WHEREAS**, Pegasus Engineering, LLC (the "Vendor") submitted a proposal dated September 9, 2024, pursuant to RFQ PW-2020-08 - Continuing On-Call Stormwater Engineering Services, to review and update the Stormwater Code, which is attached hereto and incorporated herein as Exhibit "A" (the "Proposal"); and

**WHEREAS**, the City Commission desires to authorize the City Manager or designee to approve the Vendor's Proposal in an amount not to exceed thirty thousand dollars (\$30,000.00).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. City Manager Authorized.** That the City Manager is authorized to approve the September 9, 2024, proposal from Pegasus Engineering, LLC to review and update Article IV, "Stormwater," of Chapter 98, "Natural Resources Protection," of the Land Development Code in accordance with the terms of RFQ PW-202-08 in an amount not to exceed thirty thousand dollars (\$30,00.00).

**Section 3. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 4. Effective Date.** That this Resolution shall become effective immediately upon its adoption.
