

RESOLUTION NO. 2025-151

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA; AMENDING THE DELTONA COMMISSION POLICY AND PROCEDURE POLICY NUMBER CC99-003 ELECTED OFFICIAL TRAVEL AND EXPENSES; SUPERSEDING RESOLUTIONS AND VOTES ON THE SAME SUBJECT; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.

WHEREAS, the City Commission Policy and Procedure Policy Number CC99-003 Elected Official Travel and Expenses Policy was adopted on August 2, 1999, by Resolution R-99-27 City Administrative Policy; and

WHEREAS, the City Commission has amended the Commission Policy and Procedure Policy Number CC99-003 Elected Official Travel and Expenses by resolution on February 17, 2003, by majority vote on February 7, 2005, by majority vote on July 2, 2007, and by majority vote on July 1, 2013; and

WHEREAS, the City Commission recognizes the importance of providing clear, consistent guidelines for travel and expenses incurred by elected officials while conducting official City business; and

WHEREAS, the City Commission intends to adopt an amended and restated Policy and Procedure Number CC99-003, Elected Official Travel and Expenses, to ensure accountability, transparency, and responsible stewardship of public funds; and

WHEREAS, revising this policy and procedure serves the best interests of the City; and

WHEREAS, this resolution supersedes and replaces all previous resolutions and votes regarding the Elected Official Travel and Expenses Policy, thereby maintaining the consolidation of procedural rules; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. City Commission Policy and Procedure Policy Number CC99-003 Elected Official Travel and Expenses. The City Policy and Procedure Policy

Number CC99-003 Elected Official Travel and Expenses, attached hereto as “Exhibit A,” shall be amended as presented.

Section 3. Conflicts. That all resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict. This Resolution shall supersede all prior Resolutions enumerating Commission Policy and Procedure Policy Number CC99-003 Elected Official Travel and Expenses.

Section 4. Severability. That the provisions of the City Commission Policy and Procedure Policy Number CC99-003 Elected Official Travel and Expenses are declared to be severable and if any section, sentence, clause or phrase therein shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases, but they shall remain in effect, it being the legislative intent that the City Commission Policy and Procedure Policy Number CC99-003 Elected Official Travel and Expenses shall stand.

Section 5. Effective Date. That this resolution shall take effect immediately upon its final adoption by the City Commission.
