

**RESOLUTION NO. 2025-08**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA; APPROVING APPOINTMENTS TO THE AFFORDABLE HOUSING ADVISORY COMMITTEE; PROVIDING FOR TERM OF APPOINTMENT, IMPLEMENTATION, AND AN EFFECTIVE DATE.**

**WHEREAS**, the Affordable Housing Advisory Committee (the “AHAC”) was created pursuant to pursuant to Section 2-164 of the Code of Ordinances of the City of Deltona, Florida; and

**WHEREAS**, City Code Section 2-164.01 provides for the composition and membership of the AHAC, as well as for exceptions to composition requirements should appointment pursuant to said provisions not be feasible due to reasonable factors; and

**WHEREAS**, two vacancies currently exist on the AHAC for individuals that actively serve on the local planning agency and are representative of essential services personnel; and

**WHEREAS**, the City received multiple applicants to fill said vacancies; and

**WHEREAS**, the City Commission desires to appoint \_\_\_\_\_ and \_\_\_\_\_ to the AHAC with the terms of appointment to expire on December 30, 2025.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Appointments Approved.** That the appointments of \_\_\_\_\_ and \_\_\_\_\_ to the AHAC are hereby approved.

**Section 3. Term of Appointment.** That the term of appointment for the individuals appointed shall expire on December 30, 2025.

**Section 4. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.
