

**RESOLUTION NO. 2025-10**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA; ACCEPTING A GRANT AWARD FROM THE VOLUSIA COUNTY OPIOID ABATEMENT BOARD; APPROVING THE GRANT AGREEMENT; AUTHORIZING THE CITY MANAGER AND/OR DESIGNEE TO EXECUTE THE GRANT AGREEMENT; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE.**

**WHEREAS**, the Volusia County Opioid Abatement Board has awarded the City of Deltona (the “City”) a grant award in the amount of \$350,000.00 for the funding of the Fire Department’s purchase of the AutoPulse and AutoPulse NXT® Non-invasive Cardiac Support Pump; and

**WHEREAS**, the City Commission desires to accept the Grant and approve the Grant Agreement, which sets for the terms of the Grant and is attached as “Exhibit A” (the “Grant Agreement”) and any related documents in a form approved by the City Attorney; and

**WHEREAS**, the City Commission finds that adoption of this Resolution is in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:**

**Section 1. Recitals Adopted.** That each of the above recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Grant Accepted.** That the City Commission hereby accepts the Grant awarded to the City by the Volusia County Opioid Abatement Board, in the amount of \$350,000.00, for the funding of the Fire Department’s purchase of the AutoPulse and AutoPulse NXT® Non-invasive Cardiac Support Pump, for the term set forth in the Grant Agreement.

**Section 3. Agreement Approved.** That the City Commissions hereby approves the Grant Agreement with the Volusia County Opioid Abatement Board, in substantially the form attached hereto as “Exhibit A” and hereby provides that the City Manager and/or designee is authorized to execute the Grant Agreement on behalf of the City and any related documents in a form approved by the City Attorney.

**Section 4. Implementation.** That the City Manager is hereby authorized to take any action which is necessary to implement this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.
